TERMS & CONDITIONS

PAYMENT:

- (a) 100% Payment will be made on 60th day from the date of receipt of materials and Bills at BEML PLANTS through e - mode (This holds good unless any other term of payment is mentioned in P.O.)
- (b) "OPEN ACCOUNT": i.e., 100% payment will be made on 60th day through e-mode after receipt and acceptance of the materials at our work (BEML PLANTS). Stores supplied against the purchase Order if rejected, will be returned to you by road on "FREIGHT TO PAY" basis and un-insured.
- (c) The bills to be sent, in duplicate, directly to the **Central Registry section, Earth Movers Division, BEML LTD., KGF - 563115.**

SPECIAL NOTE: You are requested to raise the invoices to the nearest rupee omitting fractions of the rupee of 0.50 & less and rounding-off fractions of 0.51 & more to the next higher rupee.

GST CLAUSE: GST will be paid extra as applicable at the time of Delivery. You should discharge GST and GST compensation cess liability and ensure filing of periodical GST returns in the manner prescribed in GST law.

The Duplicate for transporter copy is an essential document for availing input Tax Credit by the Company/Consignee as per GST law.

Accordingly, you should ensure that the Duplicate for transporter copy is sealed in a cover superscribed on the cover to read as "THIS COVER CONTAINS THE DUPLICATE FOR TRANSPORTER COPY NO.....DT...." And handed over to the company at the time of delivery, this cover is to be kept in transparent polythene cover and accompany with the material along with certificate as per proforma enclosed.

The Duplicate for transporter copy should not be detached /parted for any other purpose during transit. The transporter shall carry this Invoice.

GUARANTEE: The materials/equipment should be guaranteed for a minimum period of 12 months from the date of commissioning 18 months from the date of supply and defects, if any, arising out of faulty material, design workmanship shall be replaced /rectified by you free of cost. Please send a certificate to this effect.

This purchase order and the delivery schedule contained herein are subject to the condition that supplies pending against any earlier purchase order placed at a lower price will be completed before commencing supplies of this order.

DESPATCH/SHIPPING INSTRUCTION: You should dispatch the stores through our transport carriers, VIZ.,
M/S.....

On "Freight to pay basis" to the senior Manager-stores, BEML PLANTS. If the stores despatched other than through our transport carriers, the difference in freight charges together with other incidentals, if any, will be recovered either from your outstanding amount or directly from you. Decision of the Senior Manager - stores, BEML LIMITED, shall be final and binding on you in regard to the difference in freight charges and other incidentals.

(OR)

You should despatch the stores on "FREIGHT PAID" basis since the stores are to be delivered on FOR destination basis. If the stores are despatched on FREIGHT TO PAY basis, the freight charges and any consequential demurrages and other charges will be debited to your account. The decision of the Senior Manager-stores, BEML PLANT, shall be final and binding on you in regard to the demurrage and other charges. The supply is subject to approval by our Inspection Department at our works, BEML PLANTS.

Please indicate the Vendor Code Number and BEML Stock Number in all your documents.

LIQUIDATED DAMAGES CLAUSE : The time and date of delivery of the stores stipulated in the purchase order shall be deemed to be essence of the contract and delivery must be completed not later than the dates specified therein. Should the contractor fail to deliver the stores or any consignment there of within the period prescribed for such delivery, BEML LIMITED be entitled at their option either:

(a) To recover from the contractor as agreed damages, and not by way of penalty, a sum of 1/2% of the price of any stores which the contractor has failed to deliver as aforesaid, for each week or part of a week during which the delivery of such stores may be in arrears. The maximum liability of contractor under this clause will be limited to 5% the contract value.

(OR)

(b) To purchase elsewhere, without notice to the contractor on the account and at the risk of the contractor the stores not delivered or others of a similar description (where other exactly complying with the particulars are not in the opinion of BEML LIMITED which shall be final, readily procurable) without canceling the contract in respect of consignments not yet due for delivery.

(OR)

(c) To cancel the contract:

In the event of action being taken under (b) & (c) the contractor shall be liable for any loss which BEML LIMITED may sustain on that account but the contractor shall not be entitled to any gain on repurchase made against default.

Nos of samples / proofs should be supplied within 7 days from the date of receipt of the order for stationery items only. Bulk supplies are to be made only after receipt of approval and specific delivery schedule.

SAMPLES : Before effecting the bulk supplies and acceptable samples shall be submitted any obligation on the part of the BEML as regards safe custody and shall obtain necessary clearance for effecting bulk supplies as per schedule of delivery. Sample so supplied shall clearly labeled with suppliers name and address and purchase order number. Should any certified sample be lent by BEML the supplier shall be responsible for the safe custody and return of the same intact without any damages after the purpose for which it is given is severed without any delay or when delay or when demanded back. Any clarification regarding submission of sample may be obtained from Senior Manager Inspection and Quality Control Department of our division. If the supplier submits sample whether with before after the tender the same shall not govern the standard of supply except when it has been so specifically stated in the acceptance of tender.

In addition to the above terms and conditions, our order is also governed by General Conditions of Contract- BEML Form No. 8205350535 which is already with you / enclosed herewith.
