ANNEXURE- II SCOPE OF WORK # TERMS AND CONDITIONS

- 1. Contractor has to arrange for collection of the garbage or waste in his own arranged vehicle.
- 2. The garbage /waste kept in a prescribed place should normally be collected and moved once in a week by you or on any specified working day. However, the frequency will be regulated by giving advance information to contractor by the house keeping department from time to time.
- 3. On Sundays /Holidays, the garbage/wastes shall not be allowed for collection/disposal.
- 4. You are required to obtain necessary vehicle movement/ entry pass from the security department before commencement of work. All accessories, tools, containers, etc. for carrying out the work shall be at your cost.
- 5. Only after Security Check/clearance from the concerned Officer-in-charge you are permitted to move the garbage/waste outside the company premises as well as at the Security Gate. For this purpose a security guard will escort up to the salvage gate/main gate.
- 6. BEML will reserve the right to cancel the contract at any time without giving any notice or reasons for such cancellation.
- 7. SAFETY/ACCIDENTS: You are solely responsible for the safety of your labourers inside the factory premises. If any accident/injury occur inside our premises, you are required to arrange for necessary and immediate medical attention/treatment/compensation that may become payable.
- 8. If any salvage items other than garbage/canteen waste is disposed off in the container by over sight, upon noticing such item, either within or outside company premises, you shall return the item properly.
- 9 Any unauthorized movement of items other than specified garbage/waste, shall lead to the termination of this contract apart from forfeiting of deposit amount available with beml.
- 10. Only authorized persons/vehicles will be allowed for collection of waste every day. Entry into the premises only on production of valid entry passes, for men engaged and also for the vehicle.
- 11. Sub-contracting/ sub #leasing of this contract will automatically leads to termination of the contract.
- 12. The contractor should get the garbage being taken out weighed at our weigh bridge and the actual quantity of garbage as indicated in the weighment card will be the basis for remitting the payment by you to BEML.
- 13. The contractor should deposit sufficient money as advance to BEML, three days in advance before takingout the garbage, in the form of DD in favour of BEML limited.

14. Payments:

a. Security Deposit (SD):

The successful contractor/firm shall required to furnish security deposit of Rs 10,000/- (lumpsum) within 30 days from the date of issue of work order/sale order.
