6.#Item should be manufactured with proper JIGS / FIXTURE set up, otherwise ITEMS WILL BE REJECTED.

7.#Please assess your capacity to supply the above items before quoting.

8.#Schedules should be followed strictly, Delivery schedule is to be maintained/followed as mentioned in the Purchase Order, else PO will be short closed. LD is applicable for delayed supplies.
