Periodical oil filtration of 66/11 & 11KV Power system switchgears / Equipment / transformers to ensure required oil insulation level as per I.E. Rules.

SCOPE OF WORK:

- 1. The periodical transformer oil filtration of HT-92 transformer installation yard & 11 KV Ring Main sub-station switchgears to ensure required oil insulation level as per I.E. Rules.
- (a) The firm should check BDV of transformer oil, oil resistivity, acidity & sludge of oil, inter facial tensition of oil.

- 02. This is required for improving the dielectric level of the oil to withstand up to 50 KV for one minute Rating
- 03. BDV strength after filtering should confirm to latest relevant IS Standard
- 04. Transformer Oil testing should be done by using standard oil testing kit and should be to the Satisfaction of Engineer in-charge
- 05. The Total quantity of Transformer oil to be filtered will be calculated as per actual
- 06. The equipment ON-LINE oil filtration to be carried out as directed by Engineer in-charge without hampering the production activity to the maximum Extent.
- 07. The Provision of Power supply for the transformer filtration unit will be BEML LIMITED scope.
- 08. The Oil filtration to be carried out in co-ordination with our Engineer in-charge with out hampering the production activities
- 09. Acidity test & certificates should be arranged by you at no extra cost.
- 10. Topping up of oil should be done wherever required oil required for the same will be supplied by BEML.
- 11. The Samples to be taken before testing and after testing from the equipment and test results are to be recorded.
- 12. While carrying out the filtrations qualified supervisor with skilled operator is to be available at work spot.
