SCOPE OF WORK:

1) Firm shall carry out SWL test on EOT & JIB Cranes at EMD and HFU.

- 2) SWL test should be conducted in all movements of the Crane.
- 3) The Deflections noticed on the girders of EOT Cranes & Arm of Jib Crane has to be measured & recorded in presence of our Engineer.
- 4) Inspection to be carried out on the Hook Block, Wire Ropes, Braking Systems, Wheels, Girder Bolts & other Safety interlocks devices for safe operation of the crane. A report to this extent has to be provided in order to take Corrective action.

STATUTORY REQUIREMENTS:-

The firm's should ensure that their personnel deployed for TESTING should be covered under ESI & PF schemes/Medical insurance.

SAFETY REQUIREMENTS:-

- 1) All safety equipment such as Helmets & other equipment (as per the Inspectorate of Factories, Govt. of Karnataka) are to be positioned by the firm.
- 2) Necessary Safety precautionary measures has to be taken while conducting Load tests Any casualty or damage caused to the property or person by any untoward incidents while executing this SWL test will be at the firms risk & cost.
- 3) The firm's personnel should report to the Engineer-In-charge, Crane Maintenance and should take necessary safety permit on dailybasis before commencing the works from safety department.

TECHNICAL GENERAL TERMS & CONDITIONS:-

- 1) Minimum 6 to 8Nos EOT CRANES & 10 to 12Nos Jib Cranes per day will be released to carry out SWL test.
- 2) The certification for SWL TESTING/EXAMINATION of EOT/JIB Cranes has to be conducted by competent persons certified by Director of Factories and Boilers, Government of Karnataka as per Karnataka factory Rules, 1969. After examination of each Crane, Certificatehas to be issued in FORM NO.32 as per rule 63 and 64 of Karnataka Factories rule 1969 as per the prescribed format. A copy of the certification along with validity should be produced along with quotations.

CANTEEN FACILITIES:-

Lunch can be availed at Factory Canteen during Working Hours at cost.

ACCOMODATION:-

During Certification for SWL of EOT/JIB Cranes the accommodation will be arranged based on the availability on chargeable basis, otherwise firm has to make their own arrangements for accommodation for their personnel's.

GENERAL TERMS & CONDITIONS:-

- 1) Necessary Loads will be arranged by BEML.
- 2) Necessary instruments required for carrying out the above works are to be arranged by the firm.
- 3) Firm has to arrange for checking the Deflection of the Girder/Bridge/Jib Arm from top of the Cranes and record

- 4) The job has to be completed within 11-months from the date of release of PO.
