MANPOWER: Equipment BE1800E is 180 ton Excavator and items to be assembled are heavy components weight varying 10 to 30 ton. Consignment is expected in 8 trailers and may be in different days. Manpower deployed should be able to handle heavy jobs. Manpower should comprise minimum 02 highly skilled who can guide aligning heavy parts and giving directions to crane and others and minimum 02 skilled who can deliver aligning and mounting heavy parts as said above. Also Equipment works on 6.6 KV Motors, panels, HT cables & field switches minimum 01 person with High Voltage certified to be present. Contractor should ensure sufficient man power to complete job within 20 days after receipt of last consignment. The contractor shall deploy the manpower to carry out the complete work in one / two shifts as required. not be underage and shall meet the prevailing Laws/Act/Regulations/PF rules. All Statutory payments like provident fund contribution, ESI contribution etc. payable to the contractor's workman shall be borne by the contractor. After completion of erection and commissioning work , for 01 week or minimum 50 hours of operation in each shift 01 skilled, 02 semi skilled & 01 electrical HV certified to be provided for maintenance, inspection, checking and break down.

#### **TERMS AND CONDITIONS**

## 1. Meaning of terms used in this NIT:

#### 1.1 CONTRACTOR

Shall mean the Firm whose offer has been **accepted by BEML** and the term includes the contractor's authorized representative, successors, heirs, assignee, executors and administrators, unless excluded by the contract.

#### 1.2 SUB-CONTRACTOR

Means the person/firm named in the contract/ Work order for executing the work or any persons/firm to whom any part of the contract /work order has been given by the contractor, subject to the prior **consent given by BEML** in writing and the term includes the sub-contractors authorised representative, successors and

assignees.

#### 1.3 PROJECT – IN –CHARGE.

Means the person appointed for the duties set forth in the contract/ work order on its behalf and whose authority is notified, in writing to the contractor by BEML.

#### 1.4 CONTRACT

Means written agreement between **BEML LIMITED** AND **CONTRACTOR/FIRM** made from time to time.

#### 2. GUARANTEE PERIOD

Fitment guarantee for a period of 6 months or 1000 hrs which ever occurs earlier

#### 3. SAFETY AND SAFETY EQUIPMENTS.

Knowledge of Safety rules and regulations and ensuring their implementations and the availability of Safety Equipments, like safety gloves, safety shoes, safety goggles, safety caps (helmets), first aid boxes and welding, cutting & grinding equipment. The contractor shall adhere to various other Safety aspects as required. Contractor's workman should observe and follow the safety & DGMS regulation applicable at site during the above work. The contractor's workman should have VTC. Contractor should ensure necessary gate passes for his work men.

## 4. SECURITY

It shall be the responsibility of the Contractor to safeguard, safe handling, safe custody and safe protection of the equipments, tools & tackles. Safe custody of the tools, Accommodation and transportation of contractor's Manpower etc. will be contractor's responsibility.

#### 5. INSURANCE OF PERSONNEL ENGAGES BY CONTRACTOR:

- It shall be the Contractors responsibility to arrange for insurance cover for all the personnel engaged in repair job and related Equipments. The insurance should also cover third party liabilities. In all cases of exigencies, such as the workers falling sick, accident during the course of work, the contractor shall bear all expenses on his own account and the company shall have no liability in that behalf. Any injury to workmen during the course of work will be totally firm's responsibility and BEML will have no responsibility whatsoever in this regard

## 6. SCHEDULE/TIME PERIOD FOR ERECTION & COMMISSIONING:

- a) Unloading of consignment: Within a day or two after reaching of individual trailer. Consignment will arrive in 07 ~ 08 trailers / Consignments for each equipments.
- **b)** Equipment to be commissioned within the 20 days from the date of start of Erection activity or from the date of last consignment receipt at site/Project.
- **7. L.D. CLAUSE**: Equipment to be commissioned within 20 days from the date of start of Erection activity or the date of last consignment receipt at site/ Project. For every week of delay on contractor account, over and above the

allowed as in above, a penalty of 0.5% of the ordered value shall be levied, subject to the maximum of 5% of the *value of the contract*.

8. CRANE & Dozers: SECL shall arrange crane & Dozers to lift / move and position the equipment for commissioning work and during commissioning work.

#### 9. OTHER TERMS AND CONDITIONS:

- 1. The job has to be done in such a manner that, there is no injury/damage caused to the persons working and no damage should occur to the parts while commissioning of the machines.
- 2. Highly skilled / skiled / semi skilled / un skilled Labour required for the job to be done, are to be provided by you. Any injury to workmen during the course of work will be totally your responsibility and BEML will have no responsibility whatsoever in this regard
- 3. Crane will be provided by M/s SECL for carrying out the erection & commissioning work on the equipment depending on availability.
- 4. BEML will provide Service Engineer for providing necessary guidance to your persons/ supervisor.
- 5. You are required to observe and follow the safety regulation applicable at site during the above work. The firm has to arrange **VTC** for the personnel working on site as per the DGMS guide lines. The **list of manpower** to be deployed have to be **submitted to projects in advance at least 15 days** for VTC and gate pass. Any delay may affect commissioning.
- 6. You should ensure necessary gate passes for the work men as per mines norms.
- 7. Contractor should be ready to execute work in Project Gevra if Equipment is diverted by Customer.

# 10. Delivery schedule and Penalty:

Equipment to be commissioned within the 20 days from the date of start of Erection activity or from the date of last consignment receipt at site/ Project.

For every week of delay on contractor account, over and above the allowed as in above, a penalty of 0.5% of the order value shall be levied, subject to a maximum of 5% of the value of the contract.

#### 11. PAYMENT TERMS AND CONDITION:

# **Payment for Errection & Commissioning**

Payment will be made against invoice / billing from your side on completion of Erection & Commissioning of individual equipment as detailed below:

- i) 90% of order value after adjusting the EMD amount, subject to acceptance certificate issued by Project-in-charge (BEML) for having completed the Erection & Commissioning work. Specifying all details such as time period etc,
- ii) **10%** payment after completion of 6 months after commissioning or 1000 hrs of operation whichever occurs earlier.
- 12. COMPLIANCE OF PREVAILING STATE RULES: On receipt of the contract/work order, the contractor shall register as per WORKS CONTRACT ACT or any other prevailing rules in that state, with the concerned state government to comply with the labour laws and rules, mobilize required manpower and other infrastructure as required.

## 13. CONFIDENTIAL CLAUSE.

The contractor shall use all technical information, drawings and other advices / information provided by BEML only for execution of this contract. The contractor shall not pass on any data, material or information or drawings to other agency or use for any other purpose.

#### 14. WAGES FOR WORKMEN AND WORKMEN COMPENSATION

## a) WAGES FOR WORKMEN.

It will be the obligation of the contractor to pay reasonable wages to the workmen employed by them. However, such wages shall not be less than the wages payable under the Minimum Wages Act, 1948 or the wages notified by the respective State/central Governments who are the concerned authorities for notifying the minimum wages payable to the workmen possessing different skills and who are engaged in executing the contract. The contractor shall also be bound by the statutory provisions of the Contract Labour Regulation and Abolition Act, Apprentices Act, PSU Act, PF ACT etc., concerning the employment of the Labour by the contractor. All the obligations under the different Act provisions shall be that of the contractor and the contractor shall indemnify BEML against any or all claims in this regard.

#### **b. WORKMEN COMPENSATION**

It is also agreed that BEML shall not be liable for any compensation to be payable in respect of any workmen employed by the contractor and it shall be the sole responsibility of the contractor for payment of compensation if any, arising during the course of execution of the contract. For this purpose, the contractor shall indemnify BEML during the period of the contract against all such claims made by any person(s) employed by the contractor in execution of the contract.

BEML shall not be responsible for providing employment to contractor's labourers and or payment of any retrenchment benefits, and it shall be the duty and responsibility of the contractor to pay all terminal benefits at the time of completion of contract and shall produce satisfactory proof for having paid so,

before the final bill is settled.

## 15. Determination of lowest bidder (L-1)

Lowest bidder shall be determined on total **Erection & Commissioning** Charges quoted by the bidder for all 5 equipments.

Bidder who quoted for partial quantity of Erection & Commissioning work of equipment will summarily be rejected for this tender.

#### 16. Evaluation of Bids

Technical bid will be opened on payment towards EMD and Tender fee, then the technical evaluation of those bids will be carried out and Price bids of such agencies / firms whose technical bids are qualified as per tender terms, will be opened for further processing. The date and time of opening of Price Bids shall be informed to the technically qualified Bidders.

#### 17. SUSPENSION OF WORK

The contractor shall on written order of the Project–in–charge (BEML), suspend the progress of the works or any part thereof for such time or times and in such manner as the Project–in–Charge (BEML) may consider necessary and shall during such suspension properly protect and secure the work, so far as is necessary in his opinion.

## 18. DELAYS IN THE CONTRACTORS PERFORMANCE

The TIME SCHEDULE for commissioning as stipulated in this contract and amendment thereof shall be the ESSENCE OF THE CONTRACT.

Except as provided under force majeure clause a delay by the contactor in the performance of its delivery obligations shall render the contractor liable to the imposition of penalty as per the clause No **10**.

## 19. ASSIGNMENT SUB-LETTING AND SUB-CONTRACTING

The contractor shall not assign the contact either wholly or part thereof or any benefit or interest therein or there under without the prior written approval of BEML. The contractor shall not sublet the whole / part of the contract. However, where otherwise provided in the contract/work order the contractor may sublet a part of the contract with prior approval of BEML. But such an approval if given shall not relieve the contractor of any of the liabilities and obligations under the contract and he shall be responsible for the acts defaults and neglects of the subcontractor, his agents or workmen.

#### **20. INDEMNITY**

The contractor shall indemnify BEML at all times against all claims made by the contractors personnel and third parties in respect of any injuries accidents or any other claim in the form of compensation.

## 21. FORCE MAJEURE

The contractor shall not be responsible for any delay in execution of this contract if the delay is caused as a result of Force Majeure.

"Force Majeure" means an event beyond the control of the Contractor, such as Floods, wars or revolutions, epidemics, strikes (caused by other than contractors own employees/ workmen), terrorist attack etc.

22. Fore-Closure of Contract: If at any time after acceptance of the tender/contract BEML decide to abandon or reduce the scope of work for any reason whatsoever, Regional Manager, RO, Bilaspur shall give notice in writing to that effect to the Contractor. The compensation if any payable for such foreclosure of work will be discussed mutually between BEML and the contractor and settled after taking into consideration the loss suffered by the

Contractor on account of foreclosure of the contract. The Contractors shall have no claim to any payment of compensation or otherwise, whatsoever, on account of any profit or advantage which he might have derived consequent on foreclosure of the whole or part of the works.

#### 23. ARBITRATION CLAUSE

If BEML and the contractor are not able to resolve any contract dispute amicably within a reasonable period of time, such disputes shall be referred to a sole Arbitrator to be appointed by BEML and the proceedings before the Arbitrator shall be governed by the provisions of Arbitrations and conciliation Act 1996, in which event the Arbitration proceedings shall be held at Bangalore and the Arbitrator shall be required to give a reasoned award. Courts in Bangalore alone shall have jurisdiction in the matter.
