- 7) Offers having validity less than 120 days are liable for rejection.
- 8) Bidders quoting for lesser credit days (i.e., less than 30 days for MSME and less than 60 days for others), the interest will be added while arriving the L1 status.
- 9) Bidders indicating advance payment should submit the Bank Guarantee (BG) for 110% of the order value in advance before execution of supplies & before release of payment. In the absence of confirmation on BG for 110% value, their offers will not be considered for evaluation.
- 10) Bidders have to indicate their valid email ID and contact details on their letter head (duly signed along with company stamp/seal) and to be submitted along with the technical bid.
