1. Quotation to be submitted in two parts i.e. Technical Bid & Commercial Bid.
2. Technical Bid and Commercial Bid should be submitted through e-mode on our SRM platform only.
3. **Technical Bid:** The following documents **duly signed with seal** in all the pages should be scanned & uploaded in collaboration folder on SRM platform.
 - a) Annexure – "A" : Terms and Conditions
 - b) Annexure – "B" : Scope of Work & Other Conditions
 - c) Annexure – "C" : Format for providing Profile and other technical details of your company.
4. **A) Earnest Money Deposit: EMD** in the form of Demand Draft for Rs.24,000/- (Rupees twenty four Thousand only per vehicle) drawn in favour of BEML Ltd., payable at Bilaspur. DD should be issued from Nationalized/Scheduled Bank.
The EMD should be submitted in an envelope duly super scribing as "Demand Draft towards EMD – Tender No. 00000000" to The Regional Manager, Regional Office, BEML 1/A Sector "C", Sirgitti Industrial Area Bilaspur (C.G) Mail ID – mkv@rm.beml.co.in by 16.00 Hrs on or 23/06/2020.
B) Security Deposit :- 10% of the contract value. EMD of the qualifying party will be converted into Security Deposit and balance if any to be paid.
5. The tenderer/party may quote only for Bilaspur or for both the places i.e. Bilaspur + kusmunda/ Dipika , shall be considered. L-1 will be decided by considering individual vehicle lowest price. The bidder should mention the areas which place quoted in the bidder remarks column.
6. Quotation submitted online without submission of EMD will not be considered.
7. EMD submitted in any other form will not be accepted and the offer is liable to be rejected.
8. EMD lesser than Rs.24,000/- per vehicle will not be accepted and the quotation is liable to be rejected.
9. EMD of the unsuccessful bidder will be returned after finalization of the contract.



10. EMD of the successful bidder will be returned after submission of security deposit.
11. EMD does not carry any interest on return.
12. EMD will be forfeited if any firm withdraws the tender submitted or refuses to execute the order for reasons whatsoever.
13. **Commercial Bid:** Price bid to be submitted through E-mode as per the format given in the Item Data in SRM. The rates quoted shall be complete inclusive of the fuel charges for the vehicle, wages for the driver, maintenance charges for the vehicle, comprehensive insurance for the vehicle and the passengers and other expenses. GST shall be extra as applicable.
14. Technical Bid will be opened first and the Commercial bid of only technically accepted bids will be opened subsequently.
15. **Payment Terms:** Payment to contractor will be made within 15 days from the date of receipt of bills at RO – Bilaspur along with all requisite documents. Contractor will submit the bills (in duplicate) on monthly basis, which will be duly verified, checked and passed by BEML Ltd and forwarded to Finance Department for releasing payment to the party.
16. FAX or EMAIL quotations will not be accepted.
17. The quotation should be completed in all respects and free from ambiguity.
18. The price quoted should be valid at least for a period of 120 days from the closing date of tender.
19. BEML Ltd., reserves the right to accepted or reject any offer in full or part.
20. Offers not confirming to the above terms are liable to be ignored.
21. Canvassing by tenderers in any form including unsolicited letter on tenders submitted or post tender corrections shall render their tenders liable for rejection.

Annexure "B"**Annexure to our Tender No: 6300032938****Scope of Work & Other Conditions**

1. The vehicle deployed for the contract shall not be older than 01 year from the date of awarding the contract.
2. The vehicle deployed shall be well maintained in good running condition and road worthy to ensure smooth and trouble free service during the entire contract period.
3. Vehicle should have only yellow board with block letters.
4. Vehicle should be covered under comprehensive insurance.
5. In case of any accident or break down, the contractor should attend the formalities with the traffic police/RTO authorities including court proceeding and claims thereon under the motor vehicles act etc., If any as the case may be in such event alternative transport arrangement should be made by the contractor at his cost within one hour from the time of accident, beyond which the cost of any alternative arrangements made by BEML Ltd shall be at the cost of the travel agency.
6. The requirement of number of vehicles may be increased or decreased during the validity of the contract and contractor shall accordingly provide the vehicles. For any increase, the rates for the type of vehicle agreed upon shall also be applicable for the additional vehicle to be provided. Any increase or decrease will be intimated by BEML Ltd., 15 days in advance.
7. After entering into the contract, the vehicle deployed for BEML Ltd., contract shall be at sole disposal of BEML Ltd only and shall not be let or sublet to others, during the contract period.
8. The services of vehicles is to be provided on all days including Sunday if required from 8.00 AM to 8.00 PM. Requirement of vehicle on Sunday and Holiday if any will be intimated by BEML in advance and is to be arranged accordingly. The rates shall be quoted accordingly, no separate billing / rate will be made for Sundays or Holidays.
9. Monthly rate to be quoted is for normal usage of 12 hrs on any day i.e. between 8.00 AM to 8.00 PM. Usage of vehicle beyond this time period will be treated as additional service for which extra hour charges will be paid and is to be quoted by the bidders in the tender.
10. Monthly rate to be quoted is for normal usage of the vehicle for running of 2000 KMs per month (26/27 days). Charges for extra kilometer beyond 2000 km per month will be paid for which rate shall be quoted in by the bidders in the tender.
11. In case the vehicle is used beyond 10.00 PM, it will be treated as additional service for which driver's special allowance (Bata) will be paid and is to be quoted by the bidders in the tender.
12. In case of overnight stay during outstation travel, for which driver's special allowance (Over night stay Bata) will be paid and is to be quoted by the bidders in the tender. The contractor while claiming the Driver's bata for outstation travel (overnight stay) per day has to enclose the acknowledgement receipt from the driver of having received the payment and lodge receipt in case of night stay made by the Driver. However, in case of travel within the working place and visit to outstation places and returning on the same day outstation bata will not be paid.

13. Normal usage of the vehicle is on weekday i.e., Monday to Saturday, however, the vehicle if required on Sundays and Holidays shall also be provided.
14. Successful bidder has to submit Security Deposit (SD) at a rate of 10% of the annual contract value before commencement of the work.
Security Deposit is accepted in the form of DD or BG. The Bank Guarantee should be from any Indian Nationalized / Scheduled Banks only. The Bank Guarantee format should have the approval of BEML Ltd. The security deposit shall not carry any interest.
15. Failure to pay the security deposit shall be treated as failure to discharge the duties under the contract and shall result in cancellation of the contract awarded and the EMD amount will be forfeited. The security deposit shall be refunded within three (3) months after the date of expiry of the contract period subject to the contractor fulfilling all obligations and operations as required under the contract.
16. BEML Ltd reserves the right to appropriate the whole or any part of the amount of the security deposit without prejudice to other claims against the contractor for losses suffered by BEML due to failures on the part of the contractor or due to termination of contractor becoming disqualified because of liquidation and other reasons. Such losses, damages, charges, expenses or cost, as assumed by BEML Ltd., shall be final and binding the contractor and shall not be called into question.
17. BEML Ltd reserves the right to have parallel / similar contract with any number of contractors.
18. Earnest Money Deposit (EMD) as indicated in the NIT (Notice Inviting Tender) is to be submitted along with tender documents Technical Bid Scanned copy.
19. In case the tenderer does not commence the work or is silent for 15 days from the date of award of LOI/contract. The contract is liable to be rejected.
20. EMD given by all unsuccessful tenderers shall be refunded normally within 01 month of acceptance of award of work to the successful tenderer. EMD shall not carry any interest.
21. The tender document shall be deemed to form an integral part of the contract to be entered for this work.
22. The vehicles will normally be utilized by the officials of Bilaspur, Kusmunda and Dipika as per the timings indicated above.
23. The vehicles deployed for the contract should not be owned by BEML employees and or their dependants, the ownership details of the vehicle to be submitted by the successful bidder before deployment and if there is any contravention of this clause, the contract will be terminated immediately and the Security Deposit will be forfeited.
24. The vehicle should have been registered under section 2(35) of the Motor Vehicles Act for commercial use with RTO under taxi permit. Successful bidder shall submit documentary proof of the same before deployment.
25. The deployment of vehicle shall always be punctual. Late reporting and absence will attract penalty at the discretion of BEML Ltd.
26. Any unauthorized journey undertaken by the driver / contractor during the contract period will be disallowed and will be penalized at the discretion of BEML Ltd.
27. While deploying the vehicle, the contractor shall always ensure the following :-
 - a) Valid and relevant documents for the vehicle and driver viz., Registration Certificate, Tax paid challans / Endorsement, Insurance, Fitness Certificate, Driving Licence, Commercial use permit, emission test certificate. Etc.,

- b) Vehicle shall be in full preparedness for the full day service including the fuel in the tank, preparedness of the driver and reasonable money with the driver for meeting contingency requirements.
 - c) A mobile phone with the driver in working and charged condition.
 - d) A well equipped first aid box should always be made available in the vehicle.
 - e) Good upholstery for the seats and with cotton cloth covering on the top. The cotton cloth shall be regularly washed and maintained in hygienic condition.
 - f) Vehicle washed daily and maintained cleanly both exteriors and interiors.
 - g) Essential minimum spares viz., fan, belt, spare wheel properly inflated, spare bulb & fuses, jack, standard tools and tackles to attend to emergencies.
28. Duties and responsibilities of the driver:
- a) Driver employed for the vehicle should have minimum of 5 years experience, physically fit, having good eyesight and reflexes.
 - b) Driver shall have valid driving licence for the type of vehicle and keep it updated as and when required.
 - c) Driver should be aware of the localities and routes within Bilaspur and nearby projects.
 - d) Driver should have knowledge of Hindi, English and Chhattisgarhi languages.
 - e) Drivers shall wear white uniform – both the trousers and shirts while on duty.
 - f) While deployed for duty, the driver should be courteous to the passengers and well behaved. The driver shall open and close the doors for all the passengers while getting into and getting out of the vehicles.
 - g) The driver should get inside the vehicle only after passengers are seated and made comfortable.
 - h) While on duty to pick up guests from Railway Station / Bus Stand / Airport, the driver should display the placard at the EXIT or suitable location for welcoming the passenger.
 - i) The driver shall always park the vehicle only in the designated parking area.
 - j) The driver deployed should not be changed frequently by the contractor.
 - k) The driver shall not smoke cigarettes / bidis nor use other tobacco products while on duty.
 - l) The driver shall not spit, belch and make unsavory gestures while performing duty.
 - m) The driver shall not consume alcohol and shall not be under the influence of alcohol while on duty.
 - n) The driver shall not use mobile phone while driving; calls if any shall be attended only by stopping the vehicle at suitable location.
29. Vehicle log book should be maintained for each of the vehicle which should be maintained by the driver on the trip basis and duly certified copy of the log book by the company officials to be produced by the contractor every month while submitting the bills.
30. The contractor shall not sub-let the vehicles deployed to BEML Ltd, instances found if any will be viewed seriously and contract is liable for termination and black listing of the contractor. No correspondence shall be entertained in this regard and the decision taken by BEML Ltd is final and shall be binding on the contractor.
31. For non fulfillment of the contract conditions, BEML Ltd reserves the right to impose penalty on the contractor as follows:-
- a) For non-supply of stipulated vehicle during the month (excluding 4/5 days off in a month) penalty per day at a rate of 2 times the normal rate i.e., Monthly rate of the vehicle 26/27 days X 2 times penalty will be charged by BEML Ltd., to the contractor.

- b) In the event of the breakdown of the vehicle, alternate arrangement of similar vehicle shall be made within reasonable time by the contractor failing which penalty as above will be applicable.
 - c) For late reporting of the vehicle; Rs. 100/- for each instance for the first three instances in a month, which will be Rs. 200/- per instance thereafter.
 - d) For indulgence of disobedience / misbehavior / malpractice / fraud or any act of misdemeanor of the driver while on duty a penalty of Rs. 750/- per incidence will be levied.
32. In the event of contractor failing to provide the vehicle as above, BEML Ltd shall be at liberty to make alternate arrangements, the expenditure for such arrangements and for the loss / damage incurred by BEML Ltd as a result of such non-compliance will be deducted from the monthly running bill or security deposit of the contractor. BEML Ltd reserves the right to determine the cost of deduction at its sole discretion.
33. For repeated non-compliance of contract conditions, BEML Ltd reserves the right to terminate the contract and make alternate arrangements. The cost of making such alternate arrangements will be levied on the contractor and will be deducted from the running bills or the security deposit of the contractor.
34. BEML Ltd reserves the right to check the speedometer / odometer of the deployed vehicle at any point of time and if it is found inaccurate / tampered, suitable action deemed fit will be taken.
35. Only authorized staff attached to the contractor and driver nominated shall be allowed entry inside of the company or any other premises during the course of contract. The successful bidder shall provide the details of the drivers and authorized representatives for this purpose before commencing the work.
36. The contractor and the authorized representatives including drivers will be held responsible for any breach of the terms and conditions of the contract.
37. Accidents during the course of the work should be reported by the contractor / driver immediately to BEML Ltd., Contractor shall submit detailed report of any such accident or incident.
38. The contract will operate their vehicles entirely at their own risk and BEML Ltd shall not be held responsible for any damage / losses incurred both for the vehicle or persons traveling in the vehicle at any time.
39. The successful bidder shall ensure that all their vehicles under the contract are covered by a comprehensive insurance by a leading / reputed insurance provider. The insurance policy shall cover compensation for the loss / damage to the vehicle, driver and co-passengers as well. Under no circumstance shall BEML Ltd be liable to compensate any loss / damage that may be caused to / by the vehicle while engaged in discharge of the contractor's obligations under this contract.
40. As and when required, route permit / national permit / clearance from RTO or any other authority concerned and compliance of any other legal formalities connected with the contract have to be arranged by the contractor at his cost. BEML Ltd will not take any responsibility and will not bear any additional expenses in this regard.
41. The contractor at his own expense reinstate and make good to the satisfaction of BEML Ltd and pay compensation for any injury to any person, loss / damage occurred to any property or rights whatever including property and rights of BEML Ltd and its bonafide users of the

vehicle, for the injury, loss / damage arising out of or in connection with or during the execution of the contract and further contractor shall indemnify BEML Ltd against all claims enforceable against BEML Ltd or its bonafide users of the vehicle.

42. Price bid to be submitted through E-mode as per the format by clicking on Item Data Tab.
43. The contract shall have price variation clause on quarterly basis for providing increase / decrease in contract price in proportion to the increase / decrease in fuel price from time to time as follows(i:e: 15th March , 15th June , 15th Sept , 15th Dec of the consecutive quarters)
 - a) Fuel (Diesel) price increase / decrease up to 5% over the price existing on the date of contract shall be borne by the contractor. Price variation beyond +/-5% will be compensated by applying the following formula:-

$$\text{Price Increase or Decrease/KM: } \frac{\text{Increase or Decrease in price of Diesel}}{\text{KM per liter (Diesel Consumption) } *}$$

*For diesel consumption the average Km will be taken as 12 KMs.

- b) If the change in the fuel cost is effected in the middle of the month; then monthly rental will be computed proportionately for that month.
 - c) The cost of fuel (normal diesel) on the date of technical bid opening will be the base price for price variation clause.
44. All the offers received will be scrutinized and only technically qualified offers will be considered for Price Bid opening.
45. The Technically unqualified offers will be rejected.
46. The contract will be in force for **Two years** with a provision to extend for 1 more year , subject to satisfactory performance from the date of completion of 2 years periods of contract with the mutual consent of BEML and agency.
47. BEML Ltd reserves to short close the contract at its discretion at any point of time by giving a notice of 30 days.
48. Payment to contractor will be made within 15 days from the date of receipt of bills at RO – Bilaspur along with all requisite documents. Contractor will submit the bills (in duplicate) on monthly basis, which will be duly verified, checked and passed by BEML Ltd and forwarded to Finance Department for releasing payment to the party.
49. The actual taxi parking charges / toll charges / permit charges incurred at airports / railway stations / check posts or any other places will be reimbursed on production of actual receipt without any corrections or overwriting.
50. Disputes if any arising between the company and the supplier in connection with this purchase order or any other matters connected herewith that same will be mutually discussed and settled, failing which, the disputes shall be referred to a sole arbitrator to be appointed by BEML. The arbitration / proceedings shall be in accordance with provisions of Indian Arbitration and conciliation Act 1996 and Rules framed there under. The place of arbitration shall be at Bangalore or any other place mutually decided by and between the company and the supplier and all arbitration proceedings shall be conducted in English language. The award of the sole arbitrator shall be final and binding on all the parties.

51. In case of any suit or other legal proceedings arising under or relating to this contract, the courts at Bilaspur shall only have jurisdiction.
