## **TERMS & CONDITIONS**

1. Bidder is responsible for shifting of material within scheduled delivery period by arranging, man, materials & cranes etc. for loading from Kantatoli stores and unloading at BEML Tatisilwai land & BEML Quarter respectively and placement of materials in BEML Qtr no. 2 and at BEMl Land Tatisilwai as per instruction of stores in-charge / its representative. The entire work is on turnkey basis.

### The scope of work:-

- a) Shifting of heavy materials as per annexure A from BEML Kantatoli stores to BEML Land at Tatisilwai, Ranchi and placement of materials at BEMl Land Tatisilwai as per instruction of stores in-charge / its representative.
- b) Shifting of Miscellaneous items as per annexure B From BEML Kantatoli stores to BEML Colony, Kanke Road ,Ranchi and placement of materials in BEML Qtr no. 2 and at BEMl Land Tatisilwai as per instruction of stores in-charge / its representative.
- c) Deployment of man, machines, crane, transport vehicle for loading & unloading will be arranged by the bidder and complete the work within delivery period.

- **3.** Technical Bid and Price Bid (Part I and Part II) are to be submitted through electronic mode in the BEML SRM system. The bidder is advised to carefully go through the terms & conditions of tender before submitting the tender.
- **4.** This tender form is not transferable under any circumstance.
- 5. Fortfeiture of EMD (Earnest Money Deposit ):
  - (a) If a bidder withdraws / modifies its bid during the period of Bid validity specified by the bidder on the bid form.
  - (b) If the successful bidder withdraw the offer after the tender is submitted / acceptance of the tender.
  - (c) If the successful bidder fails to start and perform work in accordance with instruction given by BEML as per the agreed terms.
  - (d) If the contract is not performed by the successful bidder to the satisfaction of BEML.
  - (e) If there is any breach of terms and condition of the contract on the part of the successful bidder after the contract is awarded.
  - (f) In case of failure to execute the agreement.
- **6.** All entries in the tender document shall be in English either typed or written legibly in black or blue ink only. Over-writings are not permitted. All cancellations and insertions shall be duly signed / attested by the authorized person. All the documents should be uploaded in PDF format.
- **7.** Non-compliance with any of the tender conditions and incomplete, conditional and ambiguous offers are liable for rejection.

- 8. The bidder shall fill in all the required particulars in the blank space provided for the purpose in the tender document and shall also affix seal and sign on each and every page of tender document before uploading the tender on the BEML SRM System, as a token of acceptance of the tender terms & conditions. No corrections/ revisions will be entertained after closing date and time of tender.

13. Octroi and other levies, if any, in respect of destination stations shall be paid by the Bidder and claimed along with the freight charges duly supported by proper original receipts obtained from the authorities identifying the consignments. No other charges such as demurrage, retention, detention, loading / unloading, Hamali, storage charges, door collection, door delivery charges etc., will be paid by BEML under any circumstances.

Loading, Unloading and placement of material at the respective locations as instructed by stores in-charge or its representative within the premises of BEML is the responsibility of the Bidder.

**14.** Price Bid Validity: should be valid for 60 days (sixty days) from the date of tender opening.

BEML's acceptance of the tender at the quoted / negotiated rates will be binding on the bidder during the tenure of contract.

Bidders are advised to take into account all possible factors affecting fluctuations in the market rate, during the contract period.

No request for revision of rates except on account of increase/ decrease in Diesel price (as per Fuel Price Variation Formulae) will be entertained on any account during pendency of the contract.

# 17. PART II: PRICE BID

Please quote the price details in 'Item Data' BEML SRM system only against the respective items provided therein.

The rates quoted during bidding should be **single price basis** considering transportation of material from BEML Kantatoli to BEML Land Tatisilwai & BEML Qtr at Kanke road inclusive of all related operation viz. crane ,labour, transport vehicle etc. as required.

The rates should be quoted for the Activity / Routes as mentioned in the work sheet as per **Price Bid Format Annexure-D** 

# 18. Determination of Lowest Bidder (L1):-

- 16.1 In case Bidder is quoting for separate activities in price bid, then their offer shall be rejected.
- 16.2 The lowest bidder will be considered as L-1, if the offered price will be on turn-key basis.

BEML reserves right to accept or reject all tenders or any tender in part or full without assigning any reason.

# 19. Transit safety of goods:-

The bidder is liable for any loss or damage caused to BEML until the consignment is safely delivered. In case of short delivery/damages in transit, the Bidder should issue Certificates on their Letter Head to BEML at the time of affecting the delivery. In case of open delivery the Bidder Representative should sign on the format of BEML, with their official seal which is a final document for settlement of claim by BEML's underwriters immediately and BEML's underwriters prefer the claim on the Bidder at a later date and it is binding on the part of the Bidder to settle the claim within a reasonable period.

BEML's decision will be final where the materials transported are damaged and the amount of compensation payable in such cases as determined by BEML for the value of damaged / lost item is to be paid by crossed Demand Draft to BEML while submitting bill. Further, the Bidder shall be held as trustee of the consignment entrusted to him for transportation and accountable thereof accordingly. Bidder is responsible for safe delivery of consignments at assigned site and should the Bidder's vehicle meet with an accident causing loss, damage, injury or death to his or other vehicles' property or people the responsibility shall be entirely Bidder's and Bidder alone is responsible for settling all claims and or liabilities arising there from.

#### 20. <u>Completion of Work</u>:

The Bidder shall furnish a certificate within 7 days after completion of the entire work as mentioned in the scope of work.

- **21.** The vehicles should be positioned during day time only for loading. The vehicles will not be generally loaded after day time and on weekly holidays, factory holidays or on any other unforeseen holidays except under emergency/special circumstances.
  - BEML also reserves the right to enter into parallel contracts in case L-1 Bidder fails to execute the work within scheduled delivery period.
- **22.** Three copies of G.C.(Goods Consignment) Notes shall accompany the consignment.
- **23.** <u>TIME SCHEDULE</u>:- Timely delivery is the essence of the contract. The bidder shall therefore, ensure that the consignment entrusted to them for carriage is transported and delivered safely to the designated consignees/BEML- Within 30 days from the date of issuance of Work Order.
- **24.** In case of any accident, the Bidder should protect the right of recovery by lodging FIR in coordination with insurance surveyor, etc. LCV Vehicles carrying the consignment/items is not to be moved from the accident spot before the survey by the Insurance Company is done.

## 25. PENALTY CLAUSE :-

If the Bidder fails to deliver the goods within the stipulated time, then Bidder will be liable for a penalty @ 0.5% per day of the total contract value for the delayed completion of work subject to a maximum of 5 %.

#### 26. Payment:

After receiving the certificate of successful completion of the entire work to the satisfaction of BEML .The payment will be made with an approval from Chief of Stores, BEML designated unit.

The bidder has to submit bank mandate as provided by BEML to make online / RTGS payment within 21 days of submission of bills and completion certificate and other documents viz. receipted consignment note in original and challan copy.

## 27. Termination of Contract:-

Bidder should complete the entire work within 30 days from the date of issuance of work order, in case of failing to complete the work, the bidder will be informed to start the work within a week failing which the work contract for the remaining part of the job will be awarded to the L2 bidder and the decision for payment for the work completed and work left to be completed by the L1 bidder will be decided by BEML Ranchi which shall be acceptable to L1 bidder. The contract for the remaining part of the job will treated cancelled for the L1 bidder and shall be awarded to the L2 bidder as per the discretion of BEML Ltd, Ranchi which will be binding to L1 bidder.

Notwithstanding anything stated in this contract, The **Regional Manager, BEML Ltd** will have the right to terminate the contract without notice and without assigning any reason, if he is of the opinion that the Bidder is negligent in rendering services in terms of this Contract or the services rendered are not satisfactory.

## 28. BIDDER'S RESPONSIBILITY / LIABILITY:

- **27.1** The Bidder's shall always be regarded, as an independent contractor for transportation of consignment and their employees shall not at any time regarded as BEML's employees. BEML shall not be liable / responsible for any damage / loss or injury, if any, caused to the life or property of any person/s by reason of any acts of commission or negligence on the part of employees of the Bidder.
- 27.2 BEML shall not be liable / responsible for the claims, if any, of the employees of the Bidder under Workmen Compensation Act or any other enactments. The Bidder shall keep BEML fully indemnified and harmless always against all claims and proceedings, if any, of his employees or other against BEML.
- 27.3 The Bidder shall be responsible to BEML for the good behavior of his personnel whilst they are in the BEML's premises. Vehicles and personnel of the Bidder entering the BEML premises will be subject to scrutiny, check and other rules framed by BEML, Bidder shall also ensure good behavior at the time of giving delivery.

- 27.4 The Bidder shall hold BEML harmless and indemnified against all claims for damages (inclusive of legal costs in connections therewith) whether arising in consequences of personnel injury or death (irrespective of whether such claims arises in accordance with the provisions of the latest workmen's Compensation Act or any other Law in force) or to any other property by accident, negligence or otherwise arising out of and in the course of execution of the contract. And if any amount is made payable by BEML, the same shall be reimbursed to BEML immediately on receipt of a claim or the same shall be recovered out of any of the amounts due to the Bidder.
- 27.5 During the validity of the contract, the Bidder will be responsible for the safety of all the persons and BEML's property within the vicinity of the works. If there is any loss to BEML due to the negligence or fault of the Bidder or its employees or representatives the Bidder shall compensate BEML for such loss as assessed by BEML.
- 27.6 Bidder shall ensure that the vehicles used for transporting consignments are fully compliant with Emission norms & to have the renewed certificate issued by a competent authority.
- 27.7 The Bidder shall comply with /discharge all liabilities towards the labour employed under the provisions of various enactments such as latest applicable Contract Labour (Regulation and Abolition) Acts and State Govt. Rules etc., and also the provisions of all other laws such as Industrial Disputes Act, Factories Act, Employees State Insurance Act, Workmen Compensation Act, Employees Provident Fund Act, Gratuity Act., etc., as may be applicable to the Bidder and shall keep BEML fully indemnified and harmless at all times in respect of breaches, if any, of the said laws on the part of the Bidder and or on any other account.
- 27.8 BEML shall not be liable for any action direct or indirect that may be instituted by any person or body of persons or Government against the Bidders in connection with the transportation of BEML's consignments entrusted to them for transportation or any consequent liability and the Bidders shall keep BEML fully indemnified in that behalf.
- 27.9 The Bidder should ensure, vehicles used for transportation should have valid documents of registration, Insurance, Road tax, fitness permit and provide the valid Driving License & Accident free record of each driver before taking up the BEML consignment for movement. The driver of the vehicle should have the cell phone for easy communication & to know the status of the delivery then & there.

## 29. FORCE MAJEURE:

Notwithstanding anything contained in the Contract, neither the Service Provider nor the BEML shall be held responsible for total or partial non-execution of any of the contractual obligations, should the obligation become unreasonably onerous or impossible due to occurrence of a 'Force Majeure' conditions which directly affect the obligations to be performed by the BEML or the Service Provider. Such events include war, military operations of any nature, blockages, revolutions, insurrections, riots, civil commotions, insurgency, sabotage, acts of public enemy, fires, explosion, epidemics, quarantine restrictions, floods, earthquake or acts of God, restrictions by Govt. authorities over which the Service Provider or *the acts on which* the BEML has no control.

The party claiming to be affected by Force Majeure shall notify the other party in writing without delay, within two weeks on the intervention and on the cessation of such circumstance. Extension of time sought by the Service Provider along with supporting evidence and so granted by the BEML for the supply/ work affected, if any, shall not be construed as waiver in respect of remaining deliveries.

Notwithstanding above provisions, BEML shall reserve the right to cancel the order/ Contract, wholly or partly, in order to meet the overall delivery schedule and make alternative arrangements including arrangements with third party for completion of deliveries and other schedules. BEML may takeover partly processed material at a mutually agreed price.

# 30. ARBITRATION:

Regional Manger / BEML Ltd., Ranchi will be the deciding authority as regards the satisfactory performance or otherwise of the contract.

Disputes if any, arising between the company and the Bidder in connection with this Contract or any other matters connected herewith, the same will be mutually discussed and settled, failing which, the disputes shall be referred to a sole arbitrator to be appointed by BEML. The arbitration/proceedings shall be in accordance with the provisions of Indian Arbitration and Conciliation Act, 1996 and Rules framed there under. The place of arbitration shall be at Ranchi and all arbitration proceedings shall be conducted in English/Hindi language. The award of the sole arbitrator shall be final and binding on all the parties.

In case of dispute as regards the satisfactory performance or otherwise of the contract, the decision of The **Regional Manager**, **BEML Ltd** shall be final and legally binding.

All disputes and differences arising out of or in any way concerning the contract whatsoever shall be referred for decision to "The **Regional Manager, BEML Ltd**", whose decision shall be final and binding on the all parties.

#### **31. JURISDICTION:**

In respect of all matters arising out or pertaining to this tender and the contract coming into existence on acceptance thereof, the cause of action shall be deemed to have arisen only at BEML. All legal proceedings pertaining to the said contract shall be instituted in courts having territorial jurisdiction over the place where the registered office of BEML is situated, i.e. at Ranchi and no other court shall have the jurisdiction.

BEML reserves the right to accept or reject the tender in full without assigning any reason thereto.
