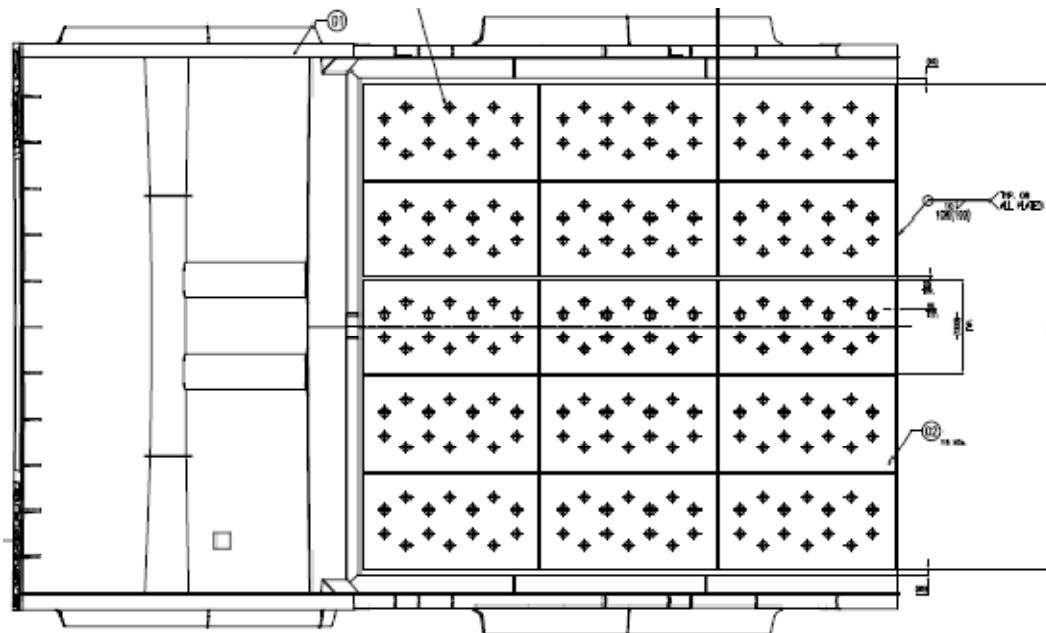

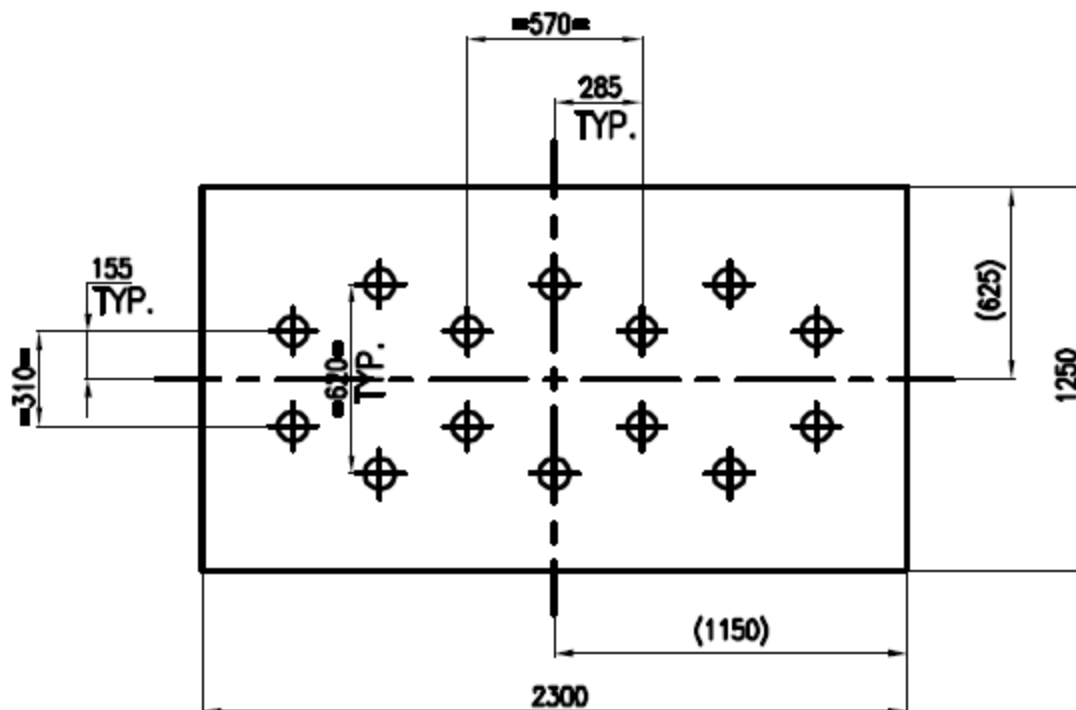
**TERMS & CONDITIONS:**

- 1) **Validity of offer:** 180 Days from the date of Tender opening.
- 2) **Site of operation:** NCL, Amlohri project, Dumper work shop.
- 3) **Schedule:** The firm has to execute the above work **within 07days** after issuance of work order
- 4) **Earnest Money deposit (EMD):**  
EMD amount of Rs.4000/- to be deposited in Electronic mode along with tender documents. For successful bidder EMD value will be remitted after completion of the job.
- 5) **Facilities can be availed from M/s. NCL:**  
Existing workshop and infrastructure facilities at Project like crane & power.
- 6) **Spares required for repair work:** Spares, like Wear plate- Floor 15nos, Wear plate- Corner 02 nos & Wear plate- Side 02nos for repair/ reinforcement of dump body will be provided by BEML.
- 7) **Sub-letting** of the awarded contract is strictly prohibited. In case of violation, the contract can be terminated with immediate effect.
- 8) **Services to be provided by the Firms:**
  - a) **For Dump Body floor/ base plate structure repairing.**
    - i. Wear plate Floor- 15nos to be welded as per procedure
    - ii. Use proper fixtures to avoid weld distortions.
    - iii. Plate and joint preparation shall confirm to standard practice
    - iv. The firm has to execute MIG welding or Metal arc welding for repair job and firm has to provide the corresponding rectifier and electrodes/ accessories accordingly.

Wear Plate –Floor 15nos to be welded as shown below sketch

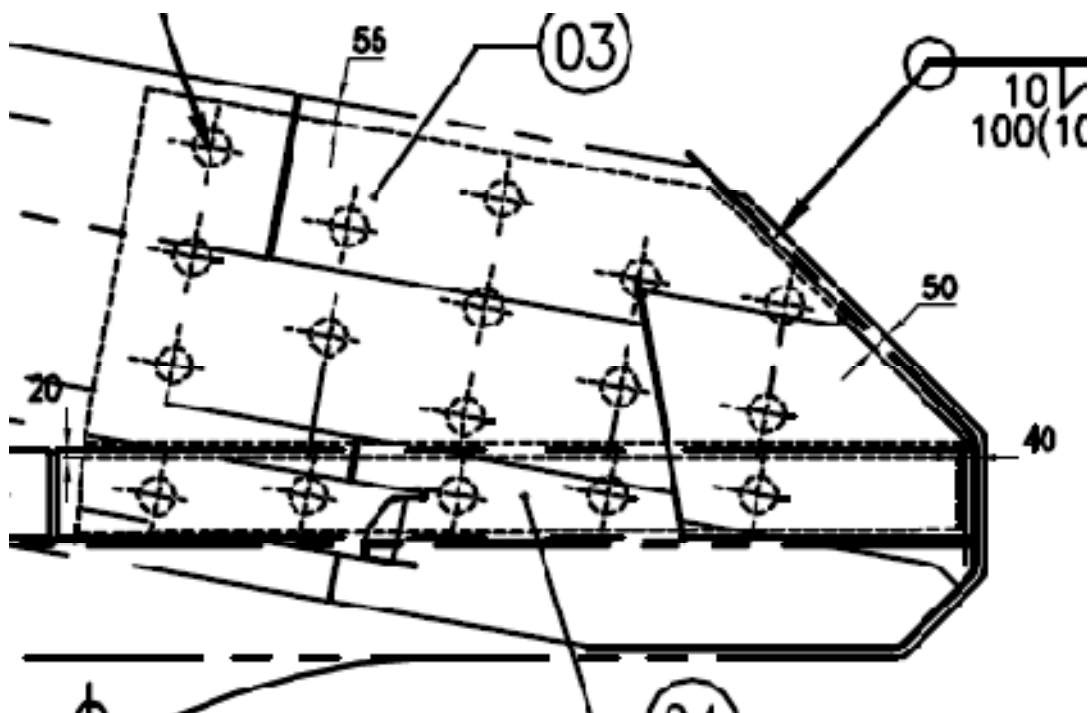


Each Wear plate – Floor (exploded view) as shown below to be welded as per procedure in base floor of dump body.

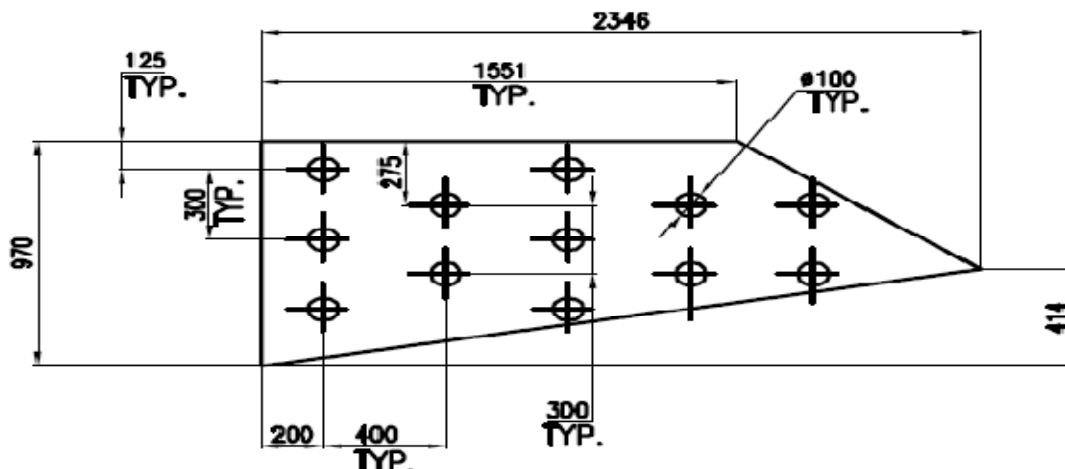


**b) For Dump Body LH & RH side corner plate repairing in Dump body.**

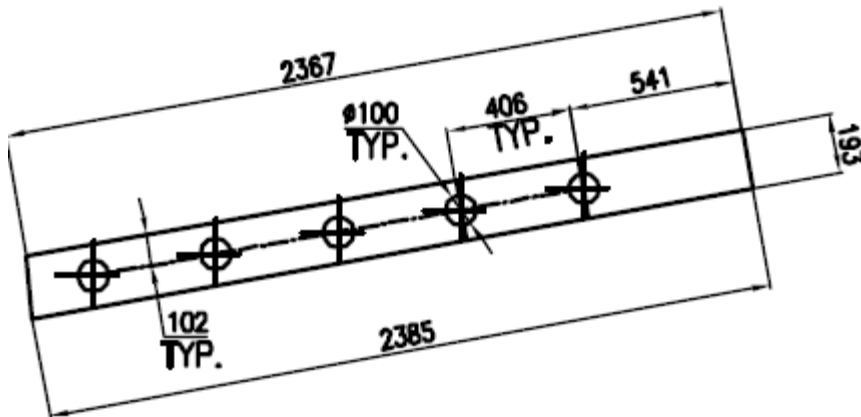
- i. Wear plate -Side 02nos & Wear plate –Corner 02nos to be welded as per procedure
- ii. Use proper fixtures to avoid weld distortions.



Details of Wear plate –Side, Qty- 02nos. Each wear plate-side to be welded as per procedure in LH& RH sides of Dump body.



Details of Wear plate –Corner, qty - 02nos. Each wear plate- corner to be welded as per procedure in LH & RH sides of Dump body.



**9) Infra structure to be provided by the Firm:**

- Firm has to provide required Welding rectifiers & accessories so that scope of work to be completed as per schedule.
- Firm has to provide required quantity of electrode for welding and all required accessories.
- Firm has to provide required quantity of Oxy-Acetylene Gas with accessories.
- Firm has to provide Grinding machine with accessories.
- Firm has to provide all required safety tools & tackles to execute the above works

**10)The manpower should have VTC** and has to be **deployed along with safety items** as per Mining rules. Manpower deployed by the **Firm shall be covered** under EPF / WC Insurance in lieu of ESI / Bonus / Minimum wages / Leave with wages (un-availed Earned leave) / Weekly off's / National and Festival Holidays and other statutory labour laws applicable, that comes to force from time to time.

**11)General security arrangement –safe custody of Firm’s belongings** like welding rectifier, Oxy- Acetylene gas set, grinding machine, all kinds of tools & tackles etc will be the sole responsibility of the Firm.

**12)Accidents, Injuries and Damages:** From commencement till completion of work, the Firm shall take full responsibility, taking precautions to prevent loss or damage. Firm shall be liable for all loss and claims, of injuries or damages to any person, which may arise during the course of work. It shall be the obligation of the Firm to pay compensation as per Employee’s compensation Act (Workmen Compensation Act). **No responsibility shall rest with BEML in this regard.**



- 13) The Firm shall take full responsibility by taking precautions to prevent loss or damage to the property of BEML Ltd. He shall be liable for any damage or loss that may happen to the works or any part thereof. In addition, the Firm shall **indemnify & keep the Company indemnified against all losses & claims for injuries or damage to any person or any property whatsoever** which may arise out of or in consequence of the works. For this purpose, **the Firm shall take 'Employees Compensation Policy or Contractors all risk coverage policy (CAR POLICY)'** to cover the risks, as per the conditions of the contract, the insurance policy has to be kept valid till the work is completed and the possession of the insurance policy is to be handed over to BEML. The policy will be taken at his cost showing **BEML as the 'PRINCIPAL'** to simplify the work in the matter of raising claims and settlements thereof.
- 14) The Firm will be solely responsible for providing uniforms, shoes, helmets & other safety items to the personnel engaged for working in the mine area as per DGMS norms.
- 15) ID cards and valid VTC's of the personnel is the responsibility of Firm.
- 16) Taxes and Duties:**
- i. Goods & Services tax (GST) at applicable rate shall be paid by the Firm as per existing rules and regulations of central / state Government requirement.
  - ii. Income tax as applicable shall be deducted from the Firm's bill at the time of payment.
  - iii. Any future upward / downward revision of all applicable taxes will be processed and paid against documentary evidence.
- 17) The bidder shall possess the digital signature as a prerequisite for submitting their offers on line through electronic tendering process authorized by M/s BEML.
- 18) PAN Number shall be provided together with authenticated copy by the Firm.
- 19) 90 % payment after the completion of the work and 10% after completion of 6 months warranty.
- 20) Copy of GST registration shall be enclosed.
- 21) Declaration for declaring that none of the relatives of the tenderer is employee of BEML Ltd. and no sister concern of the tenderer is participating in the same tender.

22) The Firm has to submit copy of **Audited Balance sheets and IT- Returns** of the previous 03 years.

**23) Termination of job work :**

Non-performance in whole or in part by the Firm of any obligation under this job work due to reasons within his control shall be treated as breach of the contract, entitling the company to terminate the contract and to recover from the Firm the cost of damages sustained by the company for such default by the Firm and due to termination of contract. BEML has the right to terminate the contract by giving written notice one month in advance.

**24) Tender Evaluation:** In case of more than one party quoted the same rate, L-1 party will be identified and finalized based on the higher value of any single work order up loaded by the party.

**25) Force majeure clause:** The awarded contract for Body repair work will be deemed short closed in the event of termination of contract between M/s BEML Ltd. and M/s NCL for any reasons what so ever.

**26) Arbitration:** If BEML Ltd. and Firm are not able to resolve any dispute amicably within a reasonable period of time, such dispute shall be referred to a sole Arbitrator to be appointed by BEML Ltd. and the proceedings before the Arbitrator shall be governed by the provisions of Arbitration and Conciliation Act 1996 in which event the Arbitration proceedings shall be held at Bangalore and the arbitrator shall be required to give reasoned award.

**27) Payment terms:** The Firm shall submit bills after satisfactory completion of job to the Accounts Department along with satisfactory performance certificates issued by USER Department, RO, Singrauli.
