4. In case of any major breakdown of any Electronic devices alternate stand by unit should be arranged by the firm to ensure smoothsurveillance operation of the system.

5. All required tools and accessories for executing the contract should be arranged by the firm.

6. All consumables including power/signal cables/connectors should be replaced in case of failure.

7. The Cost of AMC shall also include the maintenance of the UPS/SMPS/BATTERY Systems along with the CCTV System.

8. All software including VIDEOS for video capturing and recording, Windows Operating system should also be loaded and maintained during the AMC period.

9. On release of the Contract the firm should upgrade all software compatible with the present hardware, which is part of CAMC

10. Transportation charges towards supply/delivery of spares during contract period from factory to their service centre and vice-versa shall be responsibility of firm.

11. Any re-installation and commissioning should be carried by the firm during AMC period.
