OTHER TERMS & CONDITIONS:-

1. Firm has to collect BEML empty cylinders refill & supply the cylinders.
2. Please note that our cylinders are already tested by the authorized testing agency. Hence, supply need to be made in our tested cylinders only.
3. Quantity Requirement: Quantity projected is tentative requirement. BEML Ltd. reserves the right to increase/decrease the quantity during the pendency of the Purchase Order at the same terms and conditions. Indents for supplies will be given based on our requirement only. Firm has to supply as per BEML requirement and within 48 Hrs from the indent.
4. Bid should be valid for a period of minimum 60 days from date of bid opening. Quoted/finalized rates should be firm for contractperiod/till completion of supply quantity. No variation on account of market price fluctuation shall be allowed.
5. Delivery and Liquidated Damages: Delivery is the essence of this Contract. Schedules for supply will be given by BEML in advance. LD clause shall be applicable as per Terms and Conditions of BEML Ltd Purchase Order.
6. Non Performance Clause: As delivery is the essence of contract, in case of non-performance of the order placed on the firm, BEMLwill have an option of taking alternate procurement action at firm's risk & cost apart from recovery of LD and invoking the bank guarantee.
7. 30 Kgs (+) or (-) 2 Kgs to be filled in each BEML owned CO2 Cylinders.
8. Firm has to enclose purity certificate 99.90% in every consignment duly approved by competent authority/agencies.
9. Firm has to insert/close plastic dummy caps on the valve gas flowing/discharge area, in order to prevent leakage of filled gas.
10. Firm has to handle BEML owned CO2 Cylinders carefully. Firm will be held responsible for any damage/loss of cylinder during their custody.
11. While dispatching filled cylinders firm has to furnish/enclose dispatch particulars showing dispatch details like cylinder number/Tare weight, Gross weight, and Caps weight etc., details in each and every consignment without fail.
12. Firm to carry out 100% check on all the filled cylinders in all respects and ensure to dispatch only checked cylinders with duecertification by affixing sticker. The sticker should contain checked by duly signed on each sticker.
13. Successful bidder has to submit Bank Guarantee for 10% of the PO Value excluding GST.
14. Firm to indicate their acceptance to the above terms and conditions.
