Open tender in *single bid system* is invited from traders/dealers who can supply electrical items/consumables.

# **Description of Work:**

# Supply of consumables for use on 20 Cum Rope shovels are listed in page. No.8

#### Scope of work & Notes:

- 1. The tender is for entering into a rate contract for supply of various types of electrical items for a period of 02 years from the date of placement of firm Purchase order.
- 2. The quotation should clearly indicate the price of individual hardware. The quantities indicated in the tender are tentative with a variation of (+/-) 10% during placing the PO.
- 3. Electrical items to be supplied at our Regional Stores, Jhingurdah Colliery, based on the intimation at any given point of time. Firm has to arrange for the required electrical items in shortest possible time in case the same are not readily available. In case of delay in arranging the hardware, BEML reserves the right to purchase the same from other firms at their discretion. Any additional cost if incurred towards such purchase will be deducted from the firm's bill. However all efforts to be made to keep the minimum quantities of all types of specified electrical items at page no.8 at their works.
- The quoted rates should be inclusive of packing & forwarding charges including logistics & transit insurance.
- 5. The supplied items not meeting the specifications (size, grade or quality) will be summarily rejected. Firm will have to replace the same on no additional cost to BEML.
- 6. The tender document will indicate BEML part nos., specifications & sizes for ease of submission of quote.
- 7. Firm has to quote per item per quantity/meter.

8. 100% payment to the extent of stores supplied will be made within 21 days after receipt

& inspection of materials at our stores.

# (Techno-commercial – Response to be submitted)

# **1. FORCE MAJEURE**

The firm shall not be responsible for any delay in execution of this contract if the delay is caused as a result of Force Majeure.

"Force Majeure" means an event beyond the control of the Contractor, such as Floods, wars or revolutions, epidemics, strikes (caused by other than contractors own employees/ workmen), terrorist attack etc.

# 2. ARBITRATION CLAUSE

If BEML and the contractor are not able to resolve any contract dispute amicably within a reasonable period of time, such disputes shall be referred to a sole Arbitrator to be appointed by BEML and the proceedings before the Arbitrator shall be governed by the provisions of Arbitrations and conciliation Act 1996, in which event the Arbitration proceedings shall be held at Bangalore and the Arbitrator shall be required to give a reasoned award. Courts in Bangalore alone shall have jurisdiction in the matter.

# 3. APPLICABLE LAW

The contract shall be interpreted in accordance with the laws prevailing in India.

# 4. JURISDICTION OF COURTS

The courts in Bangalore only will have jurisdiction.
