- 03. ANNUAL VERIFICATION AND STAMPING OF THE WEIGHING SCALES BY LEGAL METROLOGY DEPARTMENT SHOULD BE ARRANGED BY THE CONTRACTOR WITHIN THE DUE DATE. ANY PENALTY IMPOSED DUE TO DELAYED VERIFICATION AND STAMPING SHOULD BE BORNE BY THE CONTRACTOR.
