1. Item should be manufacture and supplied as per revision - 13 drawing 774TK02113-13 Mist Brackets to P/No. 774WS11601 & 774WS11642 are part of tank structure
2. You should supply the finished item with your material as per drawing.
3. PO will be placed on the supplier/suppliers who have already developed & supplied the tank with Part No. 774TK02113. Developed sources quote will be considered for deciding L1, L2 & L3. If any New Firm/ Firms who have supplied tank with old part no's Quotes less than L1/L2/L3 price, then Development PO may be released for maximum 5 Numbers, subjected to vendor assessment and approval of the Firm by our corporate quality engineering department. Firms quoted price or BEML finalized price, whichever is lower will be offered to new sources.
4. Use CO2 Gas ARC welding
5. General welding process shall confirm to company STD. PR1004-C regarding surface preparation.
6. Anti-Corrosive Paint inside the tank surface (Ref: ISO-12944-5, System No. A6.01)
 - A. Entire internal surface has to be shot blasted to SA 2 ½ (SSPC-SP10) as per ISO 8501-1
 - B. 2-3 coat of Zinc Rich Epoxy process primer to be applied as per company STD. C6001-36 (STD shade of 446 of IS:105-latest) DFT:60 microns.
 - C. 3-5 coats of Epoxy finish painting as per company STD. C6001-37 (STD shade of 359-middle buff colour of IS:105-latest) to achieve NDTF: 360 microns.
7. Painting of outer surface of Tank Str.
 - A. External surface to be blasted to SA 2 ½ (SSPC-SP10) as per ISO 8501-1
 - B. Apply polyurethane zinc phosphate primer golden yellow as per company STD. C6001-53 (STD shade of 356 of IS:105-latest)
8. Always use 4-meter chain slings while lifting. Lifting hooks are provided to lift empty tank only

- 9.* Marked items SI no 72 (which is not shown in this drg) to be supplied in loose condition
- 10.All the skip weld gaps are to be filled with 3mm fillet weld on Baffles, Side sheet, Front and Rear sheet.
- 11.Major sub assembly items are to be checked for assembly fitness on the tank at your works with proper identification.
- 12.No water leakage / seepage shall arise through tank str / weld joints for column of 2050mm for test time of 01 hours.
- 13.Beml requires minimum 3 nos tank supply per month and schedule should be followed strictly, if not LD clause will be strictly implied.
- 14.Payment terms will be 30 days for MSME and 60 days for others from the date of receipt and acceptance.
- 15.It is essential to indicate how many WATER SPRINKLER TANKS, you can deliver every month.
- 16.Your quote should be Net-Off Scrap & should be inclusive of packing & forwarding charges
- 17.After placing the purchase order, if any firms back out or fails to supply as per our delivery schedule and quality requirement, beml has the right to purchase the same from any other supplier and any additional cost involved due to this will be recovered from the firm (original vendor on whom PO is placed).
- 18.Integrity Pact: Along with your bid submission, you have to submit integrity pact. This pact is a preliminary qualification for entering into any contract with beml for value Rs.1 crore and above. The pact will be effective from the stage of invitation of bid till the complete execution of the contract. Integrity pact to be downloaded from our web site www.bemlindia.com under purchase tab. Integrity pact to be filled, signed with firm seal and to be uploaded along with the bid.
- 19.Transportation of finished tank to BEML Mysore is under firm scope. Hence clearly indicate in your quote as F.O.R. BEML Mysore.
- 20.Quality should meet as per standards and specifications.
- 21.Beml reserves the right to inspect vendor facilities/components under manufacturing for verification of process & manufacturing capabilities and also to inspect vendor's sub-contractor's facilities.
- 22.Quality and delivery are uncompromising key factors and it is of prime importance to us; upon repeated failures, beml reserves the right to Short close / Reduce / Cancel the order placed without any further notice.
- 23.No tooling assistance will be given by BEML.
- 24.No increase of rate is permitted during the pendency of the PO.
- 25.Components should be dispatch after firm source inspection team.
- 26.Warranty Clause: In case of water leakage/cracks on the tank due to welding defects/material defects, the same to be reworked by the tank supplier at the field free of cost. Warranty period is 18 months from the date of supply of the tank or 12 months from the date of commissioning of the equipment whichever is earlier.
- 27.Secretcy clause: -
 - (a) All information, know – how, technical data, specification's, drawing models or specimens furnished by beml for the purpose of or in connection with the manufacture and supply of the stores here by ordered constitute the property of beml and that the suppliers shall keep them in strict confidence and he shall not divulge the same to anyone else except under the authority and for the purpose of beml. All such documents date & drawings models and specimens shall be property of beml and be returned to it when done with or when demanded by beml.
 - (b) The supplier shall not supply the stores ordered by beml to anyone else other than beml and shall not disclose any initiations, development or adaptations, thereof to anyone else except with the written consent of beml.
 - (c) This term contract or copy of the same in full or part thereof shall not be produced to anyone else other than to sales tax or excise authorities to whom the same shall be produced for the purpose of payment of Tax & Duties.
 - (d) BEML shall be entitled to prevent a breach of the above and to damage in case of breach.
