 Note: Servicing, Testing and Calibration of LPG Safety Relief Valves.

SCOPE OF WORK:

- 01. The firm should conduct the test on 4 Nos. Safety Relief Valves fitted on two LPG tanks (5MT and 10MT) at our works.
- 02. The firm should submit Two Copies of Original Safety Relief Valve test Certificates under rule 18 of SMPV(U) for all the Tested Valves.
- 03. The Firm should remove and fix back the Pipe line connections Safety Valves on each Tank as per our Schedule without affecting the Production.
- 04. BEML will provide the facilities like compressed air, Nitrogen Cylinder and Power supply to carry out the test at our site.
- 05. The firm should bring all the required tools (Necessary Cylinder/ Pipe line fittings), testing instruments (Calibrated PressureGauges etc.) and equipment for conducting the test by making necessary entry at our Security Gate.
- 06. After Carrying out the Safety Relief Valve Test the firm has to study the condition of the valves & other spares and their expected life and to recommend necessary spares to be replaced.
- 07. The Firm should ensure that the laborers engaged should be covered under ESI and PF scheme.
- 08. BEML will not have any kind of binding/ responsible towards compensation in case of injury/death to the firm's employees while working in BEML premises or otherwise.
- 09. 100% Payment after the completion of work and submission of Reports/Certificates subject to certification by the Maintenance department.
