In case of early supplies, payment will be made only as per the delivery schedule indicated in the purchase order and in line with the terms of payment.

If firm/firms are quoting payment terms as Advance/Proforma Invoice, firm has to agree to provide Bank Guarantee from a scheduled commercial bank for 110% of their invoice value, only then advance payment will be made. If firm does not agree for the same and only quotes for Advance/Proforma Invoice, such bids are liable for rejection and their offer will not be considered and next lowest technically acceptable offer will be considered. The BG should be valid for a period till the material is received and accepted by BEML.

2. PRICES: Prices are firm till the execution of the Order.

3. DELIVERY TERMS: Delivery as per BEML Schedule.

4. DESPATCH TERMS: F.O.R. BEML MYSORE

5. VALIDITY: 90 Days from the date of opening of the Bid. If quotation validity is less than 90 days, those quotation will be liable for rejection.

Scope of work

1. The firm shall depute their men for removal of the Gas regulator with Flow meters and refitting at the same location after due calibration of the Flow meters.
2. All the work related to calibration has to be carried out by the firm.
3. All Flow meters /instruments shall be calibrated at Our Works only. Only in certain cases with the consent of Department head, the Flow meters can be taken to the firm for calibration at their end and return.
4. Firm shall bring the Equipments/ tools required for Testing which are calibrated by competent authority and with a copy of the certificates.
5. Firm has to put sticker on all the calibrated Flow meters indicating the date of calibration and the next due date of calibration.

Terms and Conditions:

1. The period of service contract is two years (2021 & 2022). Testing has to be carried out once in a year During Dec-2021 & Dec-2022.
2. Firm shall ensure that the personnel engaged in work are covered under ESI/ PF Schemes.
3. The instruments calibrated and certified by competent authority only shall be used for calibration of our Instruments.
4. All safety precautions to be followed and BEML will not be responsible for any incident/injuries/fatal if happens to your workmen inside BEML Premises.
5. BEML will give one week advance intimation for conducting the Calibration. The Calibration work shall be taken up and completed within one week and the Firm shall furnish the Calibration certificates with in 7 days of testing.
