1.3.2 BEML reserves the right to award the contract to one or more agencies based on the commercial viability. In all the above cases, BEML reserves the right to counter offer against any specific quoted prices of L1 agencies, if they are found high on case to case basis.

2. <u>Evaluation of Bids:</u>

Envelopes received as per Part-A above will be opened first and subsequent to realization of DDs(towards EMD), technical evaluation of those bids will be carried out in line with Part-B and Price bids of such agencies/ firms whose technical bids are qualified as per tender terms, will be opened for further processing. The date and time of opening of Price Bids shall be informed to the technically qualified Bidders.

3. <u>Registration on GeM Portal:</u>

Please note that as per the directives from Ministry of Defence, registration of the vendor / service provider is mandatory for submission of bid on GeM Portal.

4. <u>GENERAL TERMS & CONDITIONS</u>

The terms "Supplier" & "Purchaser" refers to Consultant/Agency & BEML respectively in the General terms & Conditions.

4.1 **ARBITRATION:**

For PSUs: In the event of any dispute or difference relating to the interpretation and application of the provisions of this Agreement, such dispute or difference shall be referred by either party for Arbitration to the Sole Arbitrator in Department of Public Enterprises to be nominated by the Secretary to the Government of India, in charge of the Department of Public Enterprises. The Arbitration and Conciliation Act, 1996 shall not be applicable to the arbitration under this clause. The award of the Arbitrator shall be binding upon the parties to the dispute, provided, however, any party aggrieved by such Award may make further reference for setting aside or revision of the Award to the Law Secretary, Department of Legal Affairs, Ministry of Law and Justice, Government of India. Upon such reference, the dispute shall be decided by the Law Secretary or the Special Secretary/Addl. Secretary, when so authorized by the Law Secretary, whose decision shall bind the parties finally and conclusively.

For firms other than PSUs: In the event of any dispute or difference relating to the interpretation and application of the provisions of this Agreement, such dispute or difference shall be referred by either party for Arbitration to the Sole Arbitrator to be appointed by BEML. The Arbitration proceedings shall be in accordance with the provisions of Arbitration and Conciliation Act, 1996 and Rules framed thereunder. The place of Arbitration shall be at Chennai and all Arbitration proceedings shall be conducted in English language and governed by the above said Act and Rules.

Courts at Chennai shall alone have sole jurisdiction to decide any issue arising out of the Arbitration or this Agreement.

4.2 **FORCE MAJEURE CLAUSE**:

Notwithstanding anything contained in the Contract, neither the Supplier nor the Purchaser shall be held responsible for total or partial non-execution of any of the contractual obligations, should the obligation become unreasonably onerous or impossible due to occurrence of a 'Force Majeure' conditions which directly affect the obligations to be performed by the Purchaser or the Supplier. Such events include war, military operations of any nature, blockages, revolutions, insurrections, riots, civil commotions, insurgency, sabotage, acts of public enemy, fires, explosion, epidemics, quarantine restrictions, floods, earthquake, or acts of God, restrictions by Govt. authorities over which the Supplier or the acts on which the Purchaser has no control.

The party claiming to be affected by Force Majeure shall notify the other party in writing without delay, within two weeks on the intervention and on the cessation of such circumstance. Extension of time sought by the Supplier along with supporting evidence and so granted by the Purchaser for the supply/ work affected, if any, shall not be construed as waiver in respect of remaining deliveries.

Notwithstanding above provisions, Purchaser shall reserve the right to cancel the order/ Contract, wholly or partly, in order to meet the overall delivery schedule and make alternative arrangements including arrangements with third party for completion of deliveries and other schedules. Purchaser may takeover partly processed material at a mutually agreed price.

4.3 <u>APPLICABLE LAWS AND JURISDICTION OF COURTS</u>:

Indian laws both substantive and procedural, for the time being in force including modifications thereto, shall govern Contract. The competent Indian courts shall have sole jurisdiction over disputes between purchaser and the Supplier.

4.4 <u>BRIBES AND GIFTS</u>

Any bribe, commissions, gift or advantage given, promised or offered by or on behalf of the supplier or his partner, agent or servant or anyone on his or on their behalf to any officer, servant, representative or agent of BEML or any person on his or their behalf in relation to the obtaining or to the execution of or any other contract with BEML Ltd., shall in addition to any criminal liability which the supplier , may incur, subject the supplier to the cancellation of this and all other contracts with BEML and also for payment of any loss or damage resulting from any such cancellation to like extent hereof. Any question or dispute as to the commissions of any offence under the present clause shall be settled by BEML in such manner and on such evidence of information as they may think fit and sufficient and their decision shall be final and conclusive.

4.5 JURISDICTION

Courts at Chennai alone shall have jurisdiction to decide any issue/dispute arising out of the Arbitration or this Purchase Order in exclusion of all other Courts. However, jurisdiction of any other court may be accepted by mutual discussion and agreement by and between the Company and the Supplier.

4.6 **DURING ARBITRATION**

Supplies under this Purchase Order, if reasonably possible, may continue by mutual agreement during the dispute / Arbitration proceedings".

4.7 PROGRESS REPORT

The supplier shall regularly inform the progress of work and in such form as may be called for by the Purchaser from time to time. The submission and acceptance of such reports shall not prejudice the rights of the Purchaser in any manner.

4.8 CONTRACT VARIATIONS: INCREASE OR DECREASE IN THE SCOPE OF SUPPLY:

Purchaser may vary the contracted scope. If the supplier is of the opinion that the variation in scope has an effect on the agreed price or delivery period, purchaser shall be informed of this immediately in writing along with technical details, and in the event of additional work, submit a quotation with regards to the price and delivery period and the effect this scope will have on the other contracts under execution by the supplier. The supplier shall not perform additional work/ altered scope of work without the written instructions/amendment to the Purchase Order to that effect. The Purchaser also reserves its rights to decrease the scope of supply placed against Purchase Orders under due intimation to the supplier. Such decrease may be warranted due to defective goods or Policy Decisions of the Management of the Purchaser. And in such an event, the Supplier shall not have any claims or right against the Purchaser.

4.9 Payment Terms :-

- 1) Bill should be submitted on monthly basis with supporting of Trip sheet(Certified by BEML).
- 2) Payment will be released within 30 Days from the date of receipt and acceptance of bills.
- 3) GST should be filed regularly, proof of GST remittance should be submitted along with the bills, if any required.
- 4) Payment will be released only by EFT/Online mode after deduction of applicable TDS and other levies if any.

SCHEDULE-A

2. OTHERS

- 7.1 After awarding the contract to the agency, if the related documents furnished are found to be incorrect or false or fake, the agency forfeits its EMD & such agency's orders will be cancelled without any notice, apart from initiating legal action.
- 7.2 BEML reserves the right to cancel or withdraw or modify the bid without assigning any reason for such decision. Such decision will not incur any liability whatsoever on the part of BEML consequently.
- 7.3 The name and address along with seal of the authorized representative of the agency who will be interacting in future has to be furnished.
- 7.4 Fax/email quotations are not acceptable.

SCHEDULE -B

SPECIAL TERMS AND CONDITIONS (PART-B)

The tender shall be known as "Crane <u>Hire Contract on call out basis as and when required</u> <u>for Neyveli Depot.</u>"

- 1. The tender form is not transferable under any circumstances.
- 2. A prospective Bidder is expected to examine all instructions, terms and specifications in the Bid documents and fully inform himself as to all the conditions and matters which may in any way affect the scope of work or the cost thereof. Failure to furnish all information required by the Bid document or submission of a Bid not substantially responsive to the Bid document in every respect will be at the Bidder's risk and may result in the rejection of its bid.

3. EARNEST MONEY DEPOSIT (EMD)

The Bidders shall submit prescribed EMD in form of Demand Drafts through any bank payable to BEML Limited, Chennai.

The EMD shall be forfeited:

- i. If a Bidder withdraws / modifies its bid during the period of bid validity specified by the Bidder on the Bid Form; or
- ii. In case of a successful Bidder fails to sign the Contract or furnish the agreement within the prescribed date or
- iii. In case of a successful Bidder fails to furnish the Security Deposit.

4. PAYMENT MODES FOR EARNEST MONEY DEPOSIT

- 5.1 The Firm/ Agency / Institution should pay the Earnest Money Deposit (EMD) by way of Demand Draft (DD) or Online. EMD of the successful Bidder will be refunded after fulfillment of the Security Deposit/ Performance Bank Guarantee (PBG) Clause. EMD of unsuccessful bidder will be returned after finalization of contract. However, Bankers cheque may also be considered for local bidders. DD shall be in favor of "BEML Limited" payable at Chennai.
- 5.2 The deposit towards EMD shall not carry any interest.

5. PERIOD OF VALIDITY OF BIDS

Bids shall remain valid for **90 Days** from the date of bid opening.

In exceptional circumstances, BEML may solicit the Bidder's consent to an extension of the period of validity. The request and the response thereto shall be made in writing. A Bidder may refuse the request without forfeiting his bid security. A Bidder granting the request will not be required or permitted to modify its bid.

6. Security Deposit (SD):

The successful tenderer, before commencement of the Contract will have to pay Security Deposit (SD) for an amount of **Rs.50,000.00 in the form of DD for online bank payment**, to ensure safe operation of the contract. The Security Deposit (without any interest) will be returned to the contractors after successful completion of the contract. The Security Deposit will not be returned, if the performance of the contractor is not satisfactory or on account of violation of any terms and conditions of the contract. The decision of the **Manager (Finance), District Office, Chennai** will be final with regard to return of Security Deposit.

The Company (M/s. BEML Limited) reserves the right to accept or reject any tender either in full or part or to reject all tenders and it shall not be necessary for the company to assign any reason for its decision in this behalf.

- 7. Late tender and conditional tenders will be rejected. The Company does not bind itself to accept the lowest or any tender.
- 8. **PERIOD OF CONTRACT**: The contract shall remain in force for a period of **TWO YEARS** from the date of commencement of the contract with an option for the company (M/s BEML Limited) to extend it for further period/s on the same terms and conditions with the mutual consent of the Contractor.
