4. Scope: Required Plate in rectangular size will be supplied by BEML. Firm has to carry out all operations like Flame cutting, Edge preparation, Machining, Fabrication and Robot welding (FCAW/GMAW), primer painting (intergrand1032 Buff) and supply the item in ready to use condition as per drawing and TDC. (Profile machining of Centre Plate and Tail Plate of RH & LH to P/No 992MF10227, 992MF10235, 992MF10373 & 992MF10381 to be done on CNC machines only.)
5. Firm has to follow Technical delivery condition strictly as per attachment (Ref: GW/BH205E/TDC-Frame/-Rev-0 dated 20-05-2019).
6. Quality of the weld joints should conform to company STD.QY1027-C fine class
7. Weld joint inspection: DP Test shall be carried out 100% weld area compulsory as per BEML company standard QY1031-C. Ultrasonic examination of weld shall conform to company Std. QY1034-C.
