- a. In case any of our cylinder are lost or damaged by you beyond repair, we shall be charging you the cost of cylinder plus taxes if any, which is the compensation, we shall be charging value of each cylinder shall be payable by you.
- b. Cylinder Damage/Parts: If any cylinder/parts received in damaged condition which necessitates repair/replacement it will be repaired/replaced will be charged.
