Loading, Lashing, safe movement / Transportation and unloading of CMV's are Part of the activities of the Scope of the work of the Transporter and important for Safety of the consignment during transit. Mobile cranes may be outsourced by the transporter. However it is the complete responsibility of the transporter to ensure loading, lashing, safe transportation and unloading of CMV in a safe manner. Hence Tender Clause remains same.
