- c. For project management consultancy service (PMC), successful bidder has to work with executing contractors (Civil / PEB / Electrical / etc.) for timely delivery of intended Scope of Work by following all qualitative and quantitative parameters in all respect, as the construction tender is prepared with 100% GFC drawing in 3D & 2D formats. BOQs brands technical specifications, long lead items & other related information there shall be minimal. Technical clarification documents will be issued to contractors. These documents are under complete scope of consultant. In view of this, PMC service needs to ensure timely execution by contractors & co-ordinate all other related activities to SEZ requirement & Norms. It is the duty of the consultant, to ensure the executing contractor is deploying the resources as agreed by the executing contractor(s). Any delay in executing the work as reflected in the project management, penalty for delay attribute to the contractor shall be applicable for the portion related to PMC service.
- d. "As per clause 20 these are mutually dependent activities / responsibilities with executing contractors & successful bidder / consultant and extension of time shall be considered for such delay.

e. As the tender is for design & consultancy services, there is dependency on BEML for mutually dependent activities & responsibilities which are mentioned under scope of work. If the delay is attributable to BEML, penalty is not applicable & extension of time shall be considered for such activities.

f. IF THE WORKS BE DELAYED:

- i) by force majeure, or
- ii) by reasons of abnormally bad weather, or
- iii) by reasons of civil commotion, local combinations of workmen strike or lockout, affecting any of the tradesmen employed on the work, or
- iv) by reasons of delay on the part of nominated suppliers which the Contractor has in the opinion consultant taken all practical steps to avoid or reduce, or
- v) by reason of any other cause, which in the absolute discretion of Accepting Officer is beyond the control.

Then in such cases the Accepting Officer may grant fair and reasonable extension in the completion dates. Upon happening of any such event causing delay, the Consultant shall immediately, give notice but not later than 07 (seven) days thereof in writing to BEML but shall nevertheless use constantly his best endeavour to prevent or make good the delay and shall do all that may reasonably be required to the satisfaction of BEML. Extension of time as granted above shall be communicated to the Consultant by BEML in writing and shall be final and binding.

No claims in respect of compensation, loss of profit or otherwise, however, arising as a result of delay caused, extension granted shall be admitted.

(A). <u>Force Majeure:</u> The term "Force Majeure" means any event or circumstance or combination of events or circumstances that affects the performance by the Consultant of its obligations pursuant to the terms of this Contract (including by preventing, hindering or delaying such performance), but only if and to the extent that such events and circumstances are not within the Parties reasonable control and were not reasonably foreseeable and the effects of which the Party could not have prevented or overcome by acting as a Reasonable and Prudent person or, by the exercise of reasonable skill and care. Force Majeure events and circumstances to the extent they or their consequences satisfy the requirements set forth above in this Clause:

(i) The effect of any element or other act of God, including any storm, flood, drought, lightning, earthquake, tidal wave, tsunami, cyclone or other natural disaster;

- (ii) Fire, accident, loss or breakage of facilities or equipment, structural collapse or explosion;
- (iii) Epidemic, pandemic, plague or quarantine;
- (iv)War (whether declared or undeclared), sabotage, terrorism or act of public enemy (including the acts of any independent unit or individual engaged in activities in furtherance of a programme of irregular warfare), acts of belligerence of foreign enemies (whether declared or undeclared), blockades, embargoes, civil disturbance, revolution, rebellion or insurrection, exercise of military or usurped power, or any attempt at usurpation of power; radioactive contamination or ionizing radiation;

(B) Notice and Reporting:

(i) The Party, who is effected by the Force Majeure event (the effected Party), shall as soon as reasonably practicable after the date of commencement of the event of Force Majeure, but in any event no later than fourteen (14) days after such commencement date, notify the other Party in writing of such event of Force Majeure and provide the following information:

- a. Reasonably full particulars of the event or circumstance of Force Majeure and the extent to which any obligation will be prevented or delayed;
- b. Such date of commencement and an estimate of the period of time required to enable the effected Party to resume full performance of its obligations; and
- c. All relevant information relating to the Force Majeure and full details of the measures the effected Party is taking to overcome or circumvent such Force Majeure.

(ii) The effected Party shall, throughout the period during which it is prevented from performing, or delayed in the performance of, its obligations under this Contract, upon request, give or procure access to examine the scene of the Force Majeure including such information, facilities and sites as the other Party may reasonably request in connection with such event. Access to any facilities or sites shall be at the risk and cost of the effected Party requesting such information and access.

(C) Mitigation Responsibility:

(i) The effected Party shall use all reasonable endeavours, acting as a Reasonable and Prudent Person, to circumvent or overcome any event or circumstance of Force Majeure as expeditiously as possible, and relief under this Clause shall cease to be available to the effected Party if it fails to use such reasonable endeavours during or following any such event of Force Majeure.

(ii) The effected Party shall have the burden of proving that the circumstances constitute valid grounds of Force Majeure under this Clause and that it has exercised reasonable diligence efforts to remedy the cause of any alleged Force Majeure.

(iii) The effected Party shall notify the other Party when the Force Majeure has terminated or abated to an extent which permits resumption of performance to occur and shall resume performance as expeditiously as possible after such termination or abatement.

(D) <u>Consequences of Force Majeure</u> Provided that the effected Party has complied and continues to comply with the obligations of this Clause and subject to the further provisions:
 (i) the obligations of the Parties under this Contract to the extent of performance thereof is prevented or impeded by the event of Force Majeure shall be suspended and the Parties shall not be liable for the non-performance thereof for the duration of the period of Force Majeure; and

(ii) the time period(s) for the performance of the obligations of the Parties under this Contract to the extent of performance thereof is prevented or impeded by the event of Force Majeure shall be extended for the duration of the relevant period of Force Majeure except as provided herein.

(E) Force Majeure Events Exceeding 6 months

(i) If an event or series of events (alone or in combination) of Force Majeure occur, and continue for a period in excess of six (6) months, then other Party shall have the right to terminate this Contract, whereupon the Parties shall meet to mitigate the impediments caused by the Force Majeure event.
