1	Measurements of the motor grader cabin with and without the tyres installed: We need to know the exact measurements of the motor grader cabin with and without the tyres installed, as this information is crucial for transportation and logistics planning.	Measurement of Motor Grader with Cabin and Tyre is available at Annexure-C. Equipment has to be shipped to Jakarta Indonesia in fully assembled condition through container. Please see the corrigendum issued.
2	Checking with BEML for the duration of the period required to keep the vehicles lifted by cranes: We need to understand the duration for which the vehicles need to be kept lifted by cranes during the transportation process, in order to ensure smooth handling and avoid any delays.	Duration for unloading the equipment from trailer and loaded on the Container to be considered. Equipment can be positioned on wooden blocks during the Installation of Tyres and Cabin.
3	Time required for installation of all the tyres at a single stretch with the count of 3 labours provided from our end: We would like to know the estimated time required for the installation of all the tyres on the vehicles, assuming that we provide 3 labourers from our end. This will help us in planning the manpower and resources accordingly.
