INTRODUCTION AND SCOPE OF THE WORK

A. Brief about BEML and Objective of Eol:

- 1. BEML Limited is a leading multi-technology and multi-location Mini-Ratna category-I company under the Ministry of Defence offering high quality products for diverse sectors of economy such as Defence, coal, mining, steel, cement, power, irrigation, construction, road building, metro & railways and aviation. - 2. BEML Limited has manufacturing divisions at Bengaluru, Mysore, Kolar Gold Field and Pallakkad. It is proposed to have Mobile Tower installed in these complexes to cover the area for improving the telecommunication. Objective of this EOI is to identify potential Infrastructure providers who will be able to set up Mobile Tower (shared infrastructure) to improve mobile coverage in the divisions and finalise the requirements.

B. Brief Scope of Work:

For the execution of each and every listed activity, the selected telecom company (Infrastructure provider) shall constitute the Second Party, while the BEML Limited shall constitute the First Party. The selected telecom company shall have to abide by the provisions of BEML Limited along with other relevant Govt. Laws and Rules & Regulations applicable in vogue.

The expenditure for installation of Communication Towers should be incurred by the Infrastructure Provider (IP-I) / Access Service Licensees. He shall be responsible for repair, maintenance and general up keep of the tower at his own cost.

The installation of Communication Towers shall initially to be done in the presence of the staff deputed by BEML and it should in no way damage any premises/land/structure/public utilities and will not be detrimental to the safety of life/property/traffic. In case of any damage to such utilities of BEML, the infrastructure provider shall rectify the same at their own cost to the satisfaction of BEML Limited.

The Infrastructure Provider (IP-I) / Access Service Licensees shall also be responsible for the safety of tower & his staff. The security, maintenance and upkeep of the tower & land including clearing / cleaning shall be the responsibility of the Infrastructure Provider (IP-I) / Access Service Licensees.

He will be responsible for installation/providing adequate fire safety equipment's, Proper earthing of the installation, lightning protection etc.

Photography by the Infrastructure Provider (IP-I)/ Access Service Licensees or their employees of vulnerable areas, points and Defence installation in BEML will be strictly prohibited. They will abide by all security instructions of BEML as may be issued to them from time to time.

Sketch / map of the cell towers proposed locations should be provided to BEML for security checks and finalising location, specifications for further tendering.

Tenure of contract will be initially for 3 years from the date of signing the Agreement, extendable upto 5 years. License fee will be charged for the land from the date of installation.
