BEML Limited invites 'Expression of Interest (EoI)' from eligible reputed firms for Logistics Automation Process for equipment transportation for all its divisions.

Details of scope of work involved for the EoI and mode of submitting the EoI are given in the subsequent pages of this document.

Last date for submission of EoI is 17.11.2023.

Any further Addendum/ Corrigendum/ Extension of dates, Clarifications/ Responses to bidders' queries in respect of the above Eol shall be posted on BEML website (https://www.bemlindia.in) only and no separate notification shall be issued.

1. INTRODUCTION:

BEML Limited is a leading multi-technology and multi-location company under the Ministry of Defence, Government of India, offering high-quality products for diverse sectors of economy such as coal, mining, steel, cement, power, irrigation, construction, road building, aviation, defence, metro and railways.

2. PURPOSE:

BEML Limited issues Transport Contracts for transportation of Earth Moving and Defence equipments including Over Dimensional Consignments (ODCs) of BEML LIMITED from BEML manufacturing units at Palakkad / Mysore / KGF/ Bangalore to all customer sites including hilly terrain projects & all major ports of India.

Approximately 1200 trailers/trucks are used for one year for transportation of the equipments from the divisions of BEML Limited at Palakkad / Mysore / KGF/ Bangalore.

After release of the contracts, details of operation of the contract like distance travelled, time taken for travel, details of dispatch date, arrival date, distance covered, etc. are not available at present.

The purpose of this EoI is to have an automated process of the logistics involving transportation of the various equipments between various locations which will provide the details in real time to BEML Limited.

3. SCOPE OF WORK:

Following information is to be made available to BEML Limited with the automation process:

- a) Reporting of vehicles
- b) Departure date from BEML division
- c) Delivery date to customer
- d) Traceability of vehicle during transit
- e) Number of trips arranged at each division
- f) Distance admitted for each trip
- g) Utilization of contract in terms of value, number of trips, etc.
- h) Insurance availability of vehicle reported
- i) Notifications on updates of various milestones of transportation
- i) Delivery Confirmation by Transporter with signed LR document uploading
- k) Confirmation by Customer
- I) MIS Report

The software application for the automation should be an on-premise model and the Database/Application should be hosted at BEML Data Centre (hardware will be provided by BEML).

The application should meet all cyber security standards such as data encryption, Multifactor authentication, https, secured ports, etc.

Details of licensing model, implementation and training methodology are to be provided in the Eol submitted.

4. PROCESS:

The following process shall be followed:

- Issue of Eol.
- Receipt of EoI from bidders.
- Evaluation of Bidders post fulfilment of the minimum eligibility criteria including presentation of the proposed automation
- Shortlisting of the eligible EoI bidders based on eligibility criteria and presentation
- Floating of 2-bid tender to the shortlisted vendors for finalization of the vendor for implementation of the automation
- Successful bidder is required to sign Non-Disclosure Agreement (NDA) with BEML Limited

5. ELIGIBILITY CRITERIA:

Below SI. No. 1 to 6 are to be fulfilled by the firm for responding to the EoI.

6. PRESENTATION:

- The firms fulfilling the eligibility criteria will be invited to make a presentation to BEML
 Committee at a date, time and location notified by BEML.
- Firm to present their understanding, proposed methodology of implementation of the automation keeping in mind the objectives and requirements shared in this Eol.

7. FINAL EVALUATION:

Post the pre-qualification stage, the technical proposal will be evaluated on the basis of bidder's experience, its understanding of scope of services, proposed methodology and work Plan, and the experience, only those bidders whose technical marks as per the technical evaluation criteria mentioned below is 70 marks or more out of 100 shall be declared as qualified for further tendering process in two bid system. Bidders who have secured less than 70 marks shall be rejected. The Bidder with highest marks will

be given a technical score of 100 points. The technical scores of other bidders will be computed as follows:

 Firms will be shortlisted by the BEML committee members based on technical criteria and their capabilities in the presentation for further course of action as per BEML requirement.
