Sub: AMC for maintenance of RO plants at Equipment Division , EngineDivision & Township for 2 years period 1) MINIMUM ELIGIBILITY CRITERIA:

- a) The agency should be well experienced to handle periodical Servicing/ repair of RO Plants available at Beml premises. In this regard Prooffor having carried out the similar work has to be furnished.
- b) The rates quoted is per Job as specified to be valid for a period of Two years.
- 2) SCOPE OF WORK:
- a) The scope of work includes for checking the performance of RO Plant &the System and submitting a report after every visit on Monthly basis. To conduct general checkup and cleaning, chemical cleaning of cartridge, to replace spares wherever required including attending Filter media, Membranes etc., and to attend any complaints reported during the visit so as to ensure continuous output of RO water complying to all quality norms.
- b) The subject AMC also covers for preventive maintenance and as well asfor break down maintenance including repairing & fixing of allconsumables such as cartridges, multi port valve, pressure gauges, flowmeters, UV lamp, valves, end cap, membrane, worn out partsand any otherspares required for smooth operation of plants or as and when requiredto achieve the desired water quality with necessary anti scalingchemical and other such consumables for proper functioning of RO Plants.
- c) To Check & monitor the parameters & to effect necessary corrections such as, Feed pressure, reject pressure, reject flow, permitflow, conductivity, TDS, Ph Value etc., all as per the standards applicable for RO water.
- 3) General Terms & Conditions:
- a) The agency/Firm to depute qualified / experienced technicians forcarrying out the preventive maintenance & breakdown works.
- b) The agency/Firm has to visit RO plants once in a month for checkingthe efficiency & servicing of RO Plants as per the standard check listcovering for all 3 Plants.
- c) The authorized/qualified personnel must be present and guide duringcleaning of filter media, washing with HCL and during replacement of anyspares etc.<(>,<)>
- d) The agency has to maintain a register for the periodical inspectionsduly endorsed by Beml representative along with making Service repot &to submit to Beml for records/ref.
- e) The Servicing & maintenance of all 3 no. RO plants for One yearperiod by making monthly visit is considered as One Job. The paymentwill be made quarterly based on the works carried out during previousthree months followed by maintaining a register & service reports dulyacknowledged by Beml and on certification from the Civil Maintenance dept.
- f) Apart from the monthly visit, the Firm also has to visit immediatelyon receipt of any information from Beml for attending duringBreakdownswithout involving extra cost to Beml.
- g) Any lapses / delay in attending to complaints / breakdowns willattract proportionate deductions from the

payment due towards suchlapses as penalty.

- h) The Coverage for statutory compliances such as Insurances, ESI, PFetc., as applicable for the workers / staff during the visit to Beml premises is Firm#s own responsibility and Beml will not be responsible for any accident/injury happened to Firm#s personnel during their visit to our plant for servicing/maintenance.
- i)The quality of works carried out must be satisfactory and in case of any issues, the same has to be attended immediately without incurring extra cost for smooth running of RO Plants after Servicing/ Maintenance.
- j)The nominal manpower required during servicing shall be arranged byBeml.
- k) Dy Gen. Manager, Plant Engineering, Beml is the final authority incase of any dispute and for any decision regarding the satisfactory workcompletion & his decision is final & binding.
- I) Planning has to be done in advance & recommendations to be given forspares / consumables requirement during the period of AMC applicable forall 3 plants in advance with detailed specifications, market rates & thesources for our further action.
- 4) The monthly Servicing / Maintenance schedule to be carried out in the presence of authorized / technical staff deputed for the purpose as perthe following scope:
- a) Checking for product flow.
- b) Flushing of membranes with product water.
- c) Chemical cleaning of RO Membranes and Checking of membranes for biofouling, scaling, inorganic fouling, higher flow rate, lower feedtemperature including replacing of membranes if required.
- d) Checking cartridge filters.
- e) Checking the flow rate of dosing pump & servicing and replacement ifrequired.
- f) Checking of inter connector #O# ring, brine seal, end cap & cir clip& replacing the same, if required.
- g) Clearing the media with extended back wash & rinse.
- h) To Check the parameters & correct such as, feed pressure, rejectpressure, reject flow, permit flow, conductivity, TDS, Ph Value etc.<(>,<)>
- i) Replacing of various spare components related to RO Plant, such asmulti-port valve, diaphragms for diaphragm valves, UV lamp, cartridge, valves, end cap etc, any spares required in smooth operation of plant.
- j) Chemical cleaning of filtering media, if required.
- k) Probing test for membranes and physical checking of membranes.
- I) Re-arrangement of membranes, if required.
- m) Checking of lower flow rates high feed temperatures.
- n) Checking on high salt passage.
- o) Check on high differential pressure.
