- 5. The contractors are required to quote rate per day basis for Doctors and rate per month basis for nurses. The rate should be inclusive of travelling Expenses, Statutory contributions like ESI, PF, and Administrative Expenses etc.
- 6. The rate quoted for personnel shall include salary not less than minimum wages as per central government / State Government act, whichever is higher. ESI payments, PF payments, EDLI payments, Service Charges including any taxes as applicable & other statutory rules of the appropriate authorities.
- 7. The terms and conditions & special terms as given in the Annexure I & II shall also be applicable for this contract work and shall form part of the contract agreement.
- 8. This is a Service Contract for a period of **ONE YEAR**. BEML reserves the right to terminate the contract by giving 03 months' notice without assigning any reason. GENERAL TERMS AND CONDITIONS

1. The tender is for engagement of Doctor and Nurses for BEML Ltd Palakkad complex. The Contractor has to provide 1 Doctor & 2 Male Nurses with the following conditions.

Note: In the absence of regular Doctor & Nurses, alternative arrangement has to be made by the Contractor.

In case alternate Doctor/Nurses are not deputed, the payment for the shift will be deducted.

- 2. The tender forms are not transferable under any circumstances, the Contractor shall not assign or make over the contract to any other person or underlet it or make a subcontract with any workmen for the execution of any work. The contractor shall employ his own employee who shall be paid by the contractor.
- 3. The contractor shall be deemed to have studied the scope of works thoroughly before offering of his rates to ensure that the complete work is to be carried out as per requirement. The Contractors can visit the site before offering his quote if necessary.
- 4. Canvassing by tenderers or to bring political in any form, including unsolicited letters on tenders submitted or past tender corrections, shall render the respective tenders liable for summary rejection.

5. The Doctors/ Nurses deployed shall be held responsible for the stock of Medicines in the First Aid center and maintenance of appropriate records. Monthly stock verification will be carried out by BEML representative.

6. The contractor can avail canteen facilities for their Doctors/Nurses deployed inside factory on actual payment basis.

- 7. The tender shall agree not to petition for revision of rates tendered by him under any circumstances at any stage of contract either during execution or when the final claim is settled.
- 8. All entries shall be typed or written legibly in ink (green and red shall not be used) and there shall be no over-writing or erasure. All corrections should be attested by the tenderer with his dated initials as many times as the corrections occur.
- 9. The rates offered shall be indicated both in figures and in words in the respective columns, should there be difference between the amount indicated in figures and words, the lowest of the two amounts will be taken as the offer and it will be final. Tenders received after due date and time will not be accepted and the same will be returned to the tenderer.
- 10. No corrections / revision will be entertained either after the tender is submitted or after the tender closing time and date is over. Tenderers besides affixing their signatures and seal, must give their full name, address, telephone number, Telefax number if any other details.
- 11. Special Note: All taxes and duties should be quoted extra and the price quote shall be firm throughout the period of the contract. No amount shall be reimbursed on account of taxes or whatsoever may be. The quoted rate should be firm for throughout the contract.
- 12. All statutory recoveries such as ESI, PF, taxes etc., will be paid by the Contractor to the authorities concerned every month and proof thereof should be produced along with the bill for payment every month. The contractor should also submit the ESI and PF challans for having remitted the amount to the ESI and PF Authorities, indicating the amount paid and also enclosing the names of the contractor labour engaged for whom the contribution has been paid. The periodical returns in the prescribed format (Quarterly/half-yearly returns) have to be submitted concerned and the copies of the same may be submitted.
- 13. The Company (BEML LIMITED) reserves the right to accept or reject any tender either in full or in part or to reject the entire tender without assigning any reason for its decision in this regard.
- 14. Late tender and conditional tender are liable for rejection. The company does not bind to itself to accept the lowest or any other tender.

15. PERIOD OF CONTRACT:

The period of contract shall be for **ONE YEAR** from the date of commencement as per the work order, with an option for the company to extend for a further period of ONE YEAR on the same terms and conditions. BEML reserves the right to terminate the contract at any time for unsatisfactory services. The contractor shall not be entitled to claim any compensation or any damages for such termination. The company also reserved the right to award parallel contract for more than one tenderer for the above work if required.

16. The contractor has to comply with the various provisions contained in the contract labour (Regulation & Abolition) Act 1970 the rules there under.

- 17. The tender shall quote his / their firm registration / code number for the registration with ESI / PF authorities, it may be noted that other requirements being equal, preference will be given to tenderers having independent registration with ESI / PF authorities only.
- 18. Nurses without ESI registration will not be allowed to enter the premises and to carry out any work.
- 19. All statutory of ESI & EPF contribution, recovered from the labourers along with contractors matching contribution, shall be made directly to the authorities concerned as per the procedure laid down by authorities every month as per the government compliance. After remittance, the contractors have to forward as a copy of the recovery statements along with relevant challans to RPFC for their record and the same has to be submitted to the officer in charge.
- 20. The contractor will assist RPFC in settlement of the claims of their Doctor/Nurses whenever claims arise, either due to termination, discontinuance or death.
- 21. The Doctors/Nurses employed for executing the work in this contract shall be skilled, healthy and capable of doing work for which their services are intended. They shall be dutiful, obedient and execute the work assigned to them consciously and efficiently. They shall observe the timing and safety rules, discipline and conduct while working within the premises of the company.
- 22. Contract Agreement: The contractor shall execute an agreement in a stamp paper of worth Rs.100/ (rupees one hundred only) as per the format given by M/s. BEML Limited, to carry out the work coming under the scope of work and terms and condition.
- 23. The Tenderer shall read and understand special terms and condition, given terms and condition and other condition of the tender before submitting the tender for this work and shall agree to abide by the terms and condition outlined above and these documents shall form part and parcel of the contract awarded to the contractor.
- 24. **Risk Purchase clause**: BEML reserves the right for termination of the contract at any time if the services are found unsatisfactory and also has the right to award the contract to any other agency at the cost, risk and responsibilities of bidder and excess expenditure incurred on account of this will be recovered by BEML and in addition to forfeiture of security deposit towards liquidated damages.
- 25. ARBITRARION OF DISPUTES: Disputes if any arising between the parties in connection with this Agreement or any other matters connected therewith, the same will be mutually discussed and settled, failing which, the disputes shall be referred to a sole Arbitrator to be appointed by the company. The Arbitration proceedings shall be in accordance with the provisions of Arbitration and Conciliation Act 1996 and Rules Framed there under. The place of Arbitration shall be at Palakkad and all Arbitration proceedings shall be conducted in English language and governed by the above said Act and Rules framed there under and in Indian Laws. Courts at Palakkad shall alone have sole jurisdiction to decide any issue arising out of the Arbitration or this Agreement.

SPECIAL TERMS & CONDITIONS

PAYMENT OF WAGES:

The contractor shall make the payment to the personnel engaged as agreed in the commercial bid but not below the Minimum wages as applicable under the Minimum wages Act (Central/State government) whichever is higher. The contractor is also responsible for the due observance of all other laws/Rules and regulations as per Contract labours (Regulations & Abolition) Act. Contractor has to ensure that whenever the minimum wages are revised and increased by the appropriate government and notified from time to time, the same has to be complied and it is to be borne by the contractor. The contractor shall pay the wages to the personnel by 7th of every month with necessary wage slips duly mentioning the earnings and deductions in the presence of Management's representatives in accordance with the Contract Labours (Regulation and Abolition) Act and Rules made there under.

Contribution towards ESI and PF should be borne by the contractor and ensure that the payment of PF & ESI on the wages as quoted are remitted to the authorities concerned within a stipulated period.

- 2. Number of Doctors and Nurses can be increased /decreased as per the directives of the management during the contract period.
- 3. The Proof of remittance along with various register/returns has to be enclosed along with claims of the contractor monthly bills, (Evidence for having remitted PF, ESI, EDLI etc.,) for processing the bills for payment. Further, the periodical returns in respect of ESI and PF should be submitted regularly to the authorities concerned and the same has to be submitted to the Officer-in-charge.
- 4. The entry and exit of Doctor and nurses is controlled by the authorities of the company. The contractor should strictly adhere to the timings of entry and exit laid down by the authorities.
- 5. ACCIDENTS INJURIES AND DAMAGES: From commencement till completion of the contract the contractor shall take full responsibility of his Doctors & nurses and also should take precautions to prevent loss or damage. Contractor shall be liable for all loss and claims, of injuries or damages to their Doctors and nurses. For this purpose the contractor shall take an ALL RISK POLICY to cover the risk for the period of contract. Under no circumstance, the company will be liable for any such loss or claims.
- 6. In the event of any accident / injury / disablement to the Doctors and Nurses the contractor shall arrange to pay the required compensation legally payable to the concerned Doctors and Nurses dependent in addition to the medical treatment / assistance and BEML Limited shall in no way be responsible for payment of such compensation.

LABOUR ACTS:

- a. The contractor shall remain liable for the payment of all wages or other remuneration to his Doctor & Nurses under the Payment of Wages Act 1936, Workmen's Compensation Act, 1923, ESI Act 1948 or any other Acts or enactments relating thereto and rules framed there under from time to time.
- b. Doctors and Nurse In the event, the contractor fails or neglects to pay amount, due to any labour under Workmen's Compensation Act, ESI Act or other labour laws, the company is entitled to withhold the same from the amount payable to the contractor and remit the same to the authorities concerned and such payment shall be binding on the contractor. The contractor is responsible for implementing the provisions of the Contract Labour (Regulation and Abolition) Act and also responsible for any repression arising there from and noncompliance thereof.

- c. Contractor should produce muster rolls duly certified by the Officer-in-charge or his representative once in a month says before last day of each month to Officer-in-charge, so that the ESI/PF contribution amount can be ascertained and recovered.
- d. If there is any default on the part of the contractor, an estimated amount towards ESI liability including the penalty and damage will be recovered by the company from the bills of the contractors.
- e. Contractor should maintain all registers and records required for ESI. PF Payment of wages etc., under the statutes, and produces the same for verification as and when called for by the company or inspecting authorities.
- f. Contract Labour (Regulation and abolition) Act, 1970 prescribes that every contractor who employs labour for executing contract works should obtain license from labour authorities to carry out any works, so that the labourers employed by the contractor are not deprived of the facilities provided under the Act. Such license for engaging contact labour exclusively at BEML Ltd., shall be produced to BEML Ltd. Authorities before commencement of the work.
- g. The contractor is required to submit the daily attendance of Doctors and nurses engaged to the Officer-in-Charge and get a certification of the same for records.
- h. The Nurses shall not be retained on overtime work on any day. However, due to exigencies, if they are to be retained to work on any day including Sundays/Holidays, they should obtain prior approval of the Management and a copy of the approval to be enclosed along with the monthly bills for processing.
- 8. If the work is not carried out satisfactorily the contractor shall suspend the execution of the work or any part thereof whenever called upon in writing by the company and shall not resume work thereon until so intimated by the company. The contractor shall have no claim for any payment or compensation or otherwise whatsoever on account of suspension of work.
- 9. The company reserves the right to extend the term of the contract or to short close the contract at any time, without assigning any reasons.
- 10. The contractor shall arrange for the Doctors/Nurses in assigned shift subject to security check and instructions of the company rules laid down from time to time. All the Doctors and nurses shall have photo identity cards which should be produced while on duty for identification.
- 11. PAYMENT: Payment will be made on monthly basis. The Hospital shall submit bills after satisfactory completion of the work every month to the Officer-in-Charge.
