Eradication of Bee - hives at Rail Coach Unit-II for a period of 1 year/30 visits, Whichever is later.

- The work of eradication of bee-hives has to be done by spraying the chemicals only during night times from 17.30 hrs onwards.
- To the extent possible any number of colonies formed during the tendency of each operation has to be cleared off.
- After eradication of bees, the comb has to be removed and apply grease to the area & dispose to near by dustbins.
- Safety work permit has to be obtained prior to commencement on each operation.
- Eradication of bee-hives has to be carried out at any location and height.
- Sufficient help will be rendered by the company for contractors personnel to reach heights inside factory premises.
- In the event of any accident/ injury/disablement to the labour/contractor, the contractor shall pay required.
- Compensation legally payable to the concerned work man/dependent in addition to the medical treatment.
- Contractor shall take All risk insurance policy.
