TERMS & CONDITION:

1.0. Subject to the reserve price, if any fixed by the owner/stockholder M/s. Vignyan Industries Limited Tarikere (Subsidiary of BEML Ltd), or persons duly authorized in this regard (hereinafter called authority) and of the terms & conditions herein all disposal sale shall be made to the highest bidder on " **as is where is basis** " and **no complaint basis**.

2.1 Validity:

The Tenderer's must keep their quote valid for a period of 180 calendar days from the date of opening of the bid.

2.2 The buyer should pay **Earnest Money Deposit** for each Lot separately by Demand Draft of any Scheduled/Nationalized Banks **Only**. Drawn in favour of M/s. **VIGNYAN INDUSTRIES LIMITED**, Payable at **State Bank of India-branch TARIKERE** at the rate indicated against each Lot.

Bidders/Buyers may note that any payments by DD towards EMD/Deposit or other purpose received by VIL tender, on behalf of seller/Tenderer's shall be handled in good faith and intention. However VIL Tarikere shall not responsible for the loss of the DD/Cheque from its custody due to reasons beyond its control such as fire, theft, burglary, loss in transit, accident, war, riots, civil commotion, any terrorist activity, any natural calamity, adverse weather and climatic conditions etc.

Tenderer's who wish to participate in the CPCB/SPCB certified lots should provide self attested photo copies of the valid CPCB/SPCB certificates is required, on their company letter head in original, only such Tenderer's will be allowed to bid in the Tender.

3.0 INSPECTION:

3.1. The quantity, weight, quality, measurement and condition of materials indicated are all **approximate** participation and bidding by anyone in this sale shall be treated as conclusive evidence of the fact that the party has inspected the material offered for sale and satisfied himself in all respects regarding quantity, quality measurement, weight and condition of materials, taxes and duties, local working condition and other extraneous factors and the principle of Caveat of Emptor (let the buyer beware) will apply. It shall also imply and be taken for granted that the party has carefully gone through and understood the terms and conditions of auction including the amendments if any. No complaints or objection shall be entertained by VIL, TARIKERE and or the Authority after the bid is accepted.

3.2 VIL, TARIKERE - does not give warrantee or guarantee of quality, Chemical composition of each individual item in the lot or about the " End use" or fitness for a particular purpose.

4.0 PAYMENT SCHEDULE:

4.1 Full payment along with all taxes and duties to be made within 2 days from the date of confirmation for all lots.

4.2 In case of the last day of payment happens to be a closed holiday for bank the next working day will be taken as the last date of payment without penalty.

4.3 In case delay in payment as specified above, last payment charge@ 1% on the basic value for 7(seven) working days & 2% from 8th working day to 14th working days is payable by the buyers on the material value up to maximum of 14 (fourteen) working days.

5.0 TAXES & DUTIES:

5.1 All taxes or other levies charged under state, Central or local laws as applicable on the date of delivery shall be payable by the purchaser in addition to the sale value and must be deposited along with the balance purchase money as part of the purchase price.

5.2 The Tenderer's should have to submit/mention Taxes Registration number of their own like GSTN.

6.0 DELIVERY SCHEDULE:

6.1 Delivery period of 15 working days from the date full payment for all Categories.

6.2 For delivery of items of lots buyers must report by 9.00 AM on working days in the office of the VIL TARIKERE. NO delivery of the material will be given on Sunday or other holiday observed by VIL., TARIKERE. In case the last day of delivery happens to be a closed holiday for VIL., TARIKERE, the next working day will be taken as the date of lifting without any ground rent.

6.3 All delivery will commence from 9.00 AM and close at 2.00 PM on all working days.

6.4. While taking delivery of the material, it will be at the discretion of the authorized representative of VIL., TARIKERE to direct the manner/order in which the materials or lots shall be removed.

No segregation of the items of any lot is allowed inside the VIL premises.

6.5 In case the whole or any part of the goods sold remain uncleared, even after the authorized period stated in the delivery schedule, the purchaser shall have no claim whatsoever on their goods remaining uncleared and the amount paid to VIL, TARIKERE will stand forfeited at the expiry of the said period. The VIL Tarikere shall have the right to dispose of such goods in any, manner it likes. The purchaser will have no right whatsoever to any compensation. Ground rent, if any, as no date of taking delivery of the goods will be collected by VIL, TARIKERE.

6.6. Weighment recorded at VIL-TARIKERE-weighbridge will be final. The capacity of Weigh Bridge is 60MTS.

6.7. If there is any delay in lifting, beyond scheduled period from the date of delivery Ground Rent @ 1% on the basic Value for 7 (seven) working days & 2% on the basic value from 8th Working day to 14th Working day is payable by the buyers on the material value up to maximum of 14 (fourteen) working days.

6.8. Purchasers are advised in their own interest to make appointment with VIL before placement of vehicles for taking delivery of the materials purchased by them within the scheduled date of delivery. The purchaser at his own cost will make his own arrangement for removal, dismantling, loading, transporting and he will not be entitled to claim any facility or assistance or cost on this account from VIL, TARIKERE.

7.0. **GENERAL:**

7.1. Any dispute in the Tender process relating shall be decided by Tender in charge from VIL, TARIKERE, whose decision shall final and binding on all participants.

7.2. VIL-TARIKERE reserves the right to accept/reject and cancel any tender, withdraw any lot at any stage of sale after acceptance of bid/issue of disposal sale order/deposit of full value by buyer, any items by number or weight without assigning any reason thereof. Value of such material if paid for, shall be refunded, VIL-TARIKERE shall not be responsible for any damages/loss whatsoever to purchaser on account of such Withdrawal.

7.3. Re-sale will not be recognized. Disposal Sale orders will be issued in the name of the original buyer.

7.4. Segregation of material will not be allowed in the VIL-TARIKERE premises. Breaking/cutting may be allowed to the extent necessary for facilitating loading into vehicles as per the discretion of the VIL, TARIKERE, and Officials.

7.5. The goods shall remain in every respect at the risk of the purchaser from date of acceptance of his offer by VIL-TARIKERE and VIL-TARIKERE shall be under no liability for the safe custody or preservation thereof till the date of removal.

8.1. Purchaser and his men are subject to the security rule of VIL-TARIKERE in-force while in the factory Premises. The purchaser workmen, agents or representatives shall not commit any nuisance, theft or indulge in any anti-social activities in the premises and the purchaser shall be liable for the good conduct, safety and discipline of his workmen. In case of any activity, delivery will be suspended and strict action as per law will be taken including forfeiture of EMD.

8.2 The purchaser shall be responsible for any damage that may be done to premises/fittings of VIL-TARIKERE in the course of removing the lot or lots purchased by them. The authority may at its option arrange to make good such damages and the purchaser shall pay for the same on demand.

8.3 During the period the purchaser's workers are engaged within the VIL-TARIKERE premises, they will be governed by the Labour laws and rules, Factory Acts and Safety/Security Rules as applicable. It shall be responsibility of the purchaser to see that the statutory provisions are complied with.

8.4 Each lot will be sold as a complete lot as per the weight or number indicated against the lot, which is the selling quantity for delivery. The quantity indicated against each lot is approximate and no guarantee can be given regarding actual tonnage in the lot. Successful Purchaser will have to lift the entire quantity as per the tonnage given against each lot.

8.5 VIL-TARIKERE will not be in any way responsible for failure to deliver the goods as per delivery schedule to causes beyond their control such as strikes, lockouts, cessation of Labour, shortened hours, and acts of God or other causes or contingency whatsoever. The buyer shall not be entitled to cancel the contract and the period of delivery shall automatically be extended accordingly.

8.6 If any foreign materials found mixed in the lot, other than the items included in the auction sale order, VIL-TARIKERE reserves the right to remove the same at the time to delivery.

8.7 The purchaser shall ensure that emission test of the vehicle for taking out of the materials be kept within the permissible limits as prescribed by the appropriate authorities. The purchaser shall ensure that the emission test are got done by the authorized testing agency and documents shall kept in the vehicle and same to be produced when demanded by VIL-TARIKERE.

9.0 **ARBITRATION:**

9.1 Any dispute arising between the buyer and VIL-TARIKERE shall be decided by "V" the Chief of VIL & Chairman OMD, in case V is unable to arbitrate, then by such Officers of VIL-TARIKERE or any other person as the V may appoint. The decision of the Arbitration shall be final and binding on the parties subject to the provisions of Indian Arbitration Act and Rules framed hereunder shall apply.

9.2 Any dispute arising out of contract shall be decided by the court in Tarikere and by no other courts. The court in Tarikere shall have exclusive jurisdiction to adjudicate upon any such dispute.

10 Gas cutting equipment will be allowed with written permission of VIL, TARIKERE -The decision of the Officer or his authorized representative shall be final in this regard.

a All disposal sale orders, Delivery orders will be issued at M/s VIL-TARIKERE .

- b Material will be delivered after receiving full payment ONLY.
- c Taxes and duties will be as applicable at the time of delivery of the material.
- d. Buyers should possess valid GSTN number (copy of the same is required).
- e. Buyers should possess both valid Licenses of state pollution central board (SPCB) and Central pollution control (CBCB) as per note indicated in the lots.
