1. PAYMENT:

- (a) 100% Payment will be made on 60th day from the date of receipt of materials and Bills at BEML PLANTS through e mode(this hounless any other term of payment is mentioned in P.O.)
- (b) "OPEN ACCOUNT": i.e., 100% payment will be made on 60th day through e-mode after receipt and acceptance of the materials at or (BEML PLANTS). Stores supplied against the purchase Order if rejected, will be returned to you by road on FREIGHT TO PAY" basis and un-insured.
- (c) The bills to be sent, in duplicate, directly to the Central Registry section, Earth Movers Division, BEML LTD., KGF 563115.
- SPECIAL NOTE: You are requested to raise the invoices to the nearest rupee omitting fractions of the rupee of 0.50 & less and rounding-off fractio
 of 0.51 & more to the next higher rupee.
- 3. GST CLAUSE: GST will be paid extra as applicable at the time of Delivery. You should discharge GST and GST compensation cess liability and en of periodical GST returns in the manner prescribed in GST law.

The Duplicate for transporter copy is an essential document for availing input Tax Credit by the Company/Consignee as per GST law.

Accordingly, you should ensure that the Duplicate for transporter copy is sealed in a cover superscribed on the cover to read as "THIS COVER COTHE DUPLICATE FOR TRANSPORTER COPY NO.....DT...." LIQUIDATED DAMAGES CLAUSE: The time and date of delivery of the stores stipulated in the purchase order shall be deemed to be essence of the contract and delivery must be completed not later than the dates specified therein. Should the contractor fail to deliver the stores consignment there of within the period prescribed for such delivery, BEMLLIMITED be entitled at their option either:
 - (a) To recover from the contractor as agreed damages, and not by way of penalty, a sum of 1/2% of the price of any stores which the contract failed to deliver as aforesaid, for each week or part of a week during which the delivery of such stores may be in arrears. The maximum licentractor under this clause will be limited to 5% the contract value.
