### SCOPE OF SUPPLY

1. Firm should confirm that Ultra-High Purity Argon Gas supplied to be with purity of 99.9995% minimum for use in "optical emissionspectrometer".
2. Ultra-High Purity Argon Gas to be supplied in firm's returnable cylinders of 7 m3 capacity each and gas pressure should be 140-150kg/cm2
3. Firm should provide 12 holding cylinders.
4. Firm has to deliver the requested filled cylinders within 2 days from the date of mail given by BEML.
5. The firm must submit test certificate for purity level of the Argon gas with each batch of supply.
6. Acceptance of supplies shall be based on random sampling and chemical analysis of each cylinder and pressure measurement of cylinders by the end user at his end. The rejected supply shall be taken back and replacement shall be made by the supplier.
