**DESCRIPTION : - SERVICE CONTRACT FOR REMOVAL OF CHAMBERS/MANHOLES BLOCKAGE WITH MECHANIZED CLEANING IN BEML LTD, MYSORE COMPLEX FOR THE PERIOD 2021-23.(TWO YEARS)**

**Mode of measurement:**

- 1) Removal of sludge from one manhole/chambers/soak pit is considered as 1 No.
- 2) Clearing blockage from sanitary line i.e. line in between two chambers is considered as 1 No.

**TERMS & CONDITIONS**

1. The firm shall bring high pressure suction Machine/Equipment ranging from 5000 -7000 liters capacity with accessories required for subject work.
2. The work involves cleaning/removal of blockages by sucking with high pressure suction equipment & discharging sludge/sewage water. Also involves removal of blockages in sanitary lines / chamber etc. with high pressure jetting equipment.
3. The work has to be taken up immediately after receiving information from the concerned officer in charge of civil maintenance dept without any delay.
4. Required safety appliances such as Nose mask, Gum boots, Hand gloves etc., are to be provided by the firm.
5. The firms are requested to visit the spot before submitting their offers. Ignorance of site conditions at later date will not be entertained.
6. ESI, PF & other statutory requirement involved for the labours while working inside has to be taken care by the firm and Beml shall not have any liabilities in this regard. Any accident / injuries to workmen during inside has to be taken care by the firm.
7. Payment:100% payment will be made against certification by Civil Maintenance dept after satisfactory completion of work as & when required on submission of claim from the firm. 8. Validity of this contract will be for a period of Two years from the date of release of Purchase order.
