7. Canvassing by bidders in any form including un-solicited letters on tenders submitted or post tender corrections shall render their tender liable for summary rejection.
8. Price Bid Validity: The Bid should be valid for 60 days (sixty days) from the date of tender opening. BEML's acceptance of the tender at the quoted / negotiated rates will be binding on the tenderer during the tenure of contract
9. Payment term: 60 days from the date of supply duly certified by the User Department.
