1. **Earnest Money Deposit:** An amount of Rs 2500/- (Rupees Thousand Five Hundred Only) towards EMD (Earnest Money Deposit) to be deposited in BEML Account through electronic means RTGS/NEFT/any other electronic means before closing date and time of the tender.

No other mode for payment is acceptable for submission of EMD in INR

The Earnest Money Deposit will be returned to all unsuccessful bidders within a period of 30 days from the date of opening of tender. No interest shall be payable on Earnest Money Deposit in any case.

For successful bidder whose bid has been accepted and contract is awarded, the EMD shall be returned within 30 days from the date of issuance of contract.

The Security Deposit will be returned to the bidders within a period of 30 days from the date of completion of contract on submission of Invoice. No interest shall be payable on Security Deposit in any case.

3. This tender form is not transferable under any circumstances.
4. All entries in the tender document shall be in English either typed or written legibly in black or blue ink only. Over-writings are not permitted. All cancellations and insertions shall be duly signed / attested by the authorized person.
4. Non-compliance with any of the tender conditions and incomplete, conditional and ambiguous offers are liable for rejection.
5. Fax/email quotations are not acceptable.
6. BEML reserves the right to accept or reject any bid without assigning any reasons thereof.

7. **Price Bid Validity:** Offer should be valid for 90 days (Ninety days) from the date of opening of tender.

BEML's acceptance of the tender at the quoted / negotiated rates will be binding on the tenderer during the tenure of contract.

Bidders are advised to take into account all possible factors affecting fluctuations in the market rate, during the contract period.

No request for revision of rates will be entertained.

8. **Determination of Lowest Tenderer (L1):-**

- ❖ The lowest bidder as per Total charges indicated in Price Bid will only be considered as L1.
- ❖ BEML reserves right to accept or reject all tenders or any tender in part or full without assigning any reason.

9. **Transit safety of goods:-**

It shall be the responsibility of the Bidder to ensure the safety and security of the consignment entrusted to him for carriage and to effect delivery including unloading to the designated place in the same sound condition in which it would be handed over to him and within the prescribed time. The Transporting Firm shall be liable to pay for any loss or damage on account of non-delivery/short delivery of the consignments.

The Transporting Firm is liable for any loss or damage caused to BEML until the consignment is safely delivered. In case of short delivery/damages in transit, the Transporting Firm should issue Certificates on their Letter Head to BEML at the time of affecting the delivery.

Any claim made by BEML arising under this contract to be settled and paid by the Transporting Firm within fifteen days from the date of lodging claim and if there is any delay in settlement of claim interest at the rate of 20% per annum to be paid by Transporting Firm.

BEML's decision will be final if the materials transported are damaged and the amount of compensation payable in such cases as determined by BEML for the value of damaged / lost item is to be paid by crossed Demand Draft to BEML while submitting bill by transporting firm. Further, the Transporting Firm is responsible for safe delivery of consignments at assigned site and if the Transporting Firm's vehicle meet with an accident causing loss, damage, injury or death to his or other vehicles' property or people the responsibility shall be entirely Transporting Firm's alone is responsible for settling all claims and or liabilities arising there from.

11. Payment:

- ❖ No advance payment will be paid.
- ❖ After successfully completion of the contract, 100% Invoice value will be released through RTGS / NEFT within 30 days after submission of bills. After completion of the work, you will submit your Invoice along with your Bank details for RTGS / NEFT.

12. Termination of Contract

Notwithstanding anything stated in this contract, The **Regional Manager, BEML Ltd, Ranchi** will have the right to terminate the contract without notice and without assigning any reason, if he is of the opinion that the Transporting Firm is negligent in rendering services in terms of this contract.

13. Force majeure:

Notwithstanding anything contained in the Contract, neither the Service Provider nor the BEML shall be held responsible for total or partial non-execution of any of the contractual obligations, should the obligation become unreasonably onerous or impossible due to occurrence of a 'Force Majeure' conditions which directly affect the obligations to be performed by the BEML or the Service Provider. Such events include war, military operations of any nature, blockages, revolutions, insurrections, riots, civil commotions, insurgency, sabotage, acts of public enemy, fires, explosion, epidemics, quarantine restrictions, floods earthquake or acts of God, restrictions by Govt. authorities over which the Service Provider or *the acts on which* the BEML has no control.

The party claiming to be affected by Force Majeure shall notify the other party in writing without delay, within two weeks on the intervention and on the cessation of such circumstance. Extension of time sought by the Service Provider along with supporting evidence and so granted by the BEML for the supply/ work affected, if any, shall not be construed as waiver in respect of remaining deliveries.

Notwithstanding above provisions, BEML shall reserve the right to cancel the order/ Contract, wholly or partly, in order to meet the overall delivery schedule and make alternative arrangements including arrangements with third party for completion of deliveries and other schedules. BEML may takeover partly processed material at a mutually agreed price.

14. ARBITRATION:

Regional Manager, BEML Ltd, Ranchi will be the deciding authority as regards the satisfactory performance or otherwise of the contract. Disputes if any, arising between the company and

the Transporting Firm in connection with this Contract or any other matters connected herewith, the same will be mutually discussed and settled, failing which, the disputes shall be referred to a sole arbitrator to be appointed by BEML. The arbitration/proceedings shall be in accordance with the provisions of Indian Arbitration and Conciliation Act, 1996 and Rules framed there under. The place of arbitration shall be at Ranchi and all arbitration proceedings shall be conducted in English language. The award of the sole arbitrator shall be final and binding on all the parties.

In case of dispute as regards the satisfactory performance or otherwise of the contract, the decision of The **Regional Manager, BEML Ltd, Ranchi** shall be final and legally binding.

All disputes and differences arising out of or in any way concerning the contract whatsoever shall be referred for decision to “The **Regional Manager, BEML Ltd, Ranchi**”, whose decision shall be final and binding on the all parties.

15. JURISDICTION:

In respect of all matters arising out or pertaining to this tender and the contract coming into existence on acceptance thereof, the cause of action shall be deemed to have arisen only at BEML. All legal proceedings pertaining to the said contract shall be instituted in courts having territorial jurisdiction over the place where the registered office of BEML is situated, i.e. at Ranchi and no other court shall have the jurisdiction.

16. BEML reserves the right to accept or reject tender without assigning any reason thereto.
