**1. Samples:**

Kindly supply sample packet of Sweets and Khara (1/2 kg of sweet one packet, ¼ kg of sweet one packet and 150 grams mixture) at the time of submission of EMD as detailed in the Annexure C should be submitted to **The General Manager, BEML Ltd, Room No. 1, BEML Soudha, No. 23/1, 4th Main, SR Nagar, Bangalore-27** before the closing Date and time i.e **07/10/2021 before 14.00 hrs.**

**2. Earnest Money Deposit (EMD):**

1. Earnest Money Deposit (EMD) should be submitted for the value of **Rs. 2,000/- (Rupees Two Thousand Only) in the form of Demand Draft / Banker’s Cheque only drawn in favour of BEML Ltd., Bangalore, payable at Bangalore.** Vendors exempted from EMD shall attach exemption certificate from competent authority.
2. EMD submitted in any other form will not be accepted and the quotation will be rejected.
3. EMD of DD lesser than Rs.2,000/- will not be accepted and the quotation is liable to be rejected.

The name and address of the bidder shall be printed or writing legibly on the left hand bottom corner of the envelope.
