- 6. Testing should be carried out without disturbing our regular production activities.
- 7. Contractor is responsible if any damage is happened on BEML eqpts/machines and penalty will be recovered from the vendor's bill.
- 8. Scope of the vendor covers all the risks on their staff.
- 9. Period of completion including certification should be within 10 days from the issue of Purchase order.
- 10. The Contractor have proper valid license authorized by Kerala State Factories and Boilers. Copy of the same to be enclosed with offer.
- 11. Should have minimum 3 years' experience for similar testing. Supporting documents to be attached.
